

# McKibben Demographics

## Opinions of Options A, B, and C


- It is correct for LCSC to shift student enrollment to one or more schools north of Perry-Worth. All three options appropriately address the need to redistrict now. Travel times to new elementary schools for addresses effected by the redistricting are consistent with neighboring districts, districts across Indiana, and schools across the country.
- Capacity exists at Central, Hattie B. Stokes, and Perry-Worth to absorb enrollment growth of current Perry-Worth attendance boundary over the next 10-year period.
- Future enrollment growth is likely to occur north, west, and and within the City of Lebanon. **Existing home sales increases are likely to occur first in the City of Lebanon due to the aging population.** Existing home sales tends to have an earlier and more dramatic effect on student enrollment than the construction and sales of new homes.
- Student enrollment growth in current new neighborhoods in Whitestown will eventually level and slow as students age out of elementary school and eventually graduate. Existing homes will cease to produce students as the empty nester population of Whitestown will grow over the next 10+ years.
- **It would be unwise to consider an additional elementary school in the southeast portion of the school district** due to current elementary schools' student capacity, and the eventual population growth balanced from north to south and east to west in the school district. A more suitable location for future schools would likely be north or northwest of Whitestown.
  - It is wise to increase capacity at Lebanon Middle School.

# LEBANON COMMUNITY SCHOOL CORPORATION FORECAST ASSUMPTIONS

- a. The national, state or regional economy does not go into deep recession at anytime during the 10 years of the forecasts; (Deep recession is defined as four consecutive quarters where the GDP contracts greater than 1% per quarter)
- b. Interest rates have risen from their historic lows and will not fluctuate more than two percentage points in the short term; the interest rate for a 30-year fixed home mortgage stays between 5.0% and 7.0% for the 10 years of the forecasts;
- c. The rate of mortgage approval stays at 2024 levels and lenders do not return to “sub-prime” mortgage practices;
- d. There are no additional restrictions placed on home mortgage lenders or additional bankruptcies of major credit providers;
- e. The rate of housing foreclosures does not exceed 125% of the 2015-2023 average of Boone County for any year in the forecasts;
- f. All currently planned, platted, approved, and permitted housing developments are built out and completed by 2033. All new housing units constructed are occupied by 2034. Speculative new home construction plans are not included;
- g. The average annual unemployment rates for Boone County and the Indianapolis Metropolitan Area will remain below 7.5% for the 10 years of the forecasts;
- h. The intra-district student transfer policy remains unchanged over the next 10 years;
- i. The rate of students transferring out of the Lebanon Community School Corporation will remain at the AY2018-19 to AY2023-24 average;
- j. The inflation rate for gasoline will stay below 5% per year for the 10 years of the forecasts;
- k. The state of Indiana does not change the current policy on open enrollment (unrestricted inter district transfers) or school vouchers anytime in the next 10 years;

# LEBANON COMMUNITY SCHOOL CORPORATION FORECAST ASSUMPTIONS

- I. There will be no building moratorium within the district;
- m. Businesses within the district and the Lebanon Community School Corporation area will remain viable, all current economic development projects come to fruition;
- n. There will be no new charter schools opened in the district anytime or expansion of existing charter schools over the next 10 years;
- o. The number of existing home sales in the district that are a result of "distress sales" (homes worth less than the current mortgage value) will not exceed 20% of total homes sales in the district for any given year;
- p. Housing turnover rates (sale of existing homes in the district) will remain at their current levels. The majority of existing homes sold are those of homeowners over the age of 60;
- q. The district will have at least an average of 720 existing home sales per year for the next 10 years;
- r. The district will have at least an average of 310 new single-family housing units constructed per year over the next 10 years;
- s. The district will continue to average a net loss of -550 students annually from public-to-public transfers, charter schools, out of district virtual programs and private school vouchers;
- t. Private school and home school attendance rates will remain constant at AY2024 levels;
- u. The rate of foreclosures for commercial property remains at the 2015-2023 average for Boone County;
- v. The number of students engaging in virtual learning (both within and outside of the district) remains at the AY2024 level.





## TOTAL POPULATION—2020 CENSUS





# CENTRAL ELEMENTARY TOTAL POPULATION—2020 CENSUS





# HARNEY ELEMENTARY TOTAL POPULATION—2020 CENSUS





# STOKES ELEMENTARY TOTAL POPULATION—2020 CENSUS







Elementary Enrollment Forecast by 2034 = 1975


Elementary Capacity by 2025-26 = +2475

Middle School Capacity by 2027-28 = +1200


High School Enrollment Forecast by 2034 = 1297






