Bluebonnet Math Curriculum Update – Dr. Chris Jackson		
<ul style="list-style-type: none"><li>• Started with HB 1605</li><li>• Materials can be used for two years</li><li>• CISD committee formed in December</li><li>• District committee unanimously approved to move forward with math materials</li><li>• Contracted with the State</li><li>• Focus on PLCs will shift</li><li>• The State Board has a ten-year plan implementing more subjects even pulling in CTE programs</li></ul>
