Bids for the construction of the Project will be received at the Lyon County School District (LCSD) located at 25 E. Goldfield, Yerington, Nevada 89447, until Monday, May 5, 2025 at 1:00 PM local time. At that time the Bids received will be publicly opened and read.

The Work generally includes but is not limited to the construction of a concrete pad and aggregate base pad for installation of a modular building and utility service connections as further described below.

Parking Lot and Site Improvements

Owner anticipates that the Project's total bid price will be approximately **\$80,000**. The Project has an expected duration of **120 days**.

Successful Bidders will be required to furnish both a Payment Bond and Performance Bond in the full amount of the contact price.

The **Owner** will not award the Contract to a Bidder who, at the time of submitting a Bid, was not properly licensed under the provisions of Chapter 624 of NRS or if the Contract would exceed the limit of the Bidder's license. Bidders shall submit proof of qualifications to perform the Work as described in the Instructions to Bidders.
