2.a. Student Activity Trip Presentation... Ms. Shade

Ms. Shade addressed the Board regarding a student activity trip to Costa Rica in 2027 she wants to have. This is her 3rd year teaching here at CASH in biology and conservation science. She proposed a 9 day tour through Education Tours. The dates are June 21, to 29, 2027 at a cost of \$3,759/student and adults \$4,579 with 28 monthly payment options. This pricing includes round trip airfare and tour transportation, hotels, breakfast and dinner, full time tour director and daily activities, tours and entrances to attractions. Global travel protection, early enrollment discounts, general liability insurance and the EF's Peace of Mind Program. She anticipates 12 students to be interested.
