Task 1:

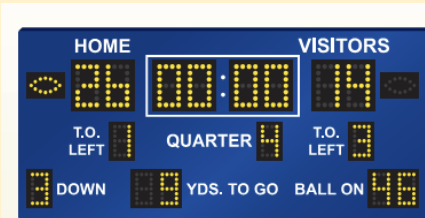
You plant a spruce tree that grows 4 inches per year and a hemlock tree that grows 6 inches per year. The initial heights of the trees are shown. After how many years will the trees be the same height?

(excluding the boundary in the case of a strict inequality), and graph the solution set to a system of linear inequalities in two variables as the intersection of the corresponding half-planes.



Task 2:

In a football game, all of the home team's points are from 7-point touchdowns and 3-point field goals. The team scored six times. Find the numbers of touchdowns and field goals that the home team scores.



Task 3:

You spend \$20 total on tubes of paint and disposable brushes for an art project. Tubes of paint cost \$4.00 each and brushes cost \$0.50 each. You purchase twice as many brushes as tubes of paint. How many brushes and tubes of paint do you purchase?
