Regular Session

Board President Emily Davies called the meeting to order at 7:03 pm. Board members present were Emily Davies, Levi Mallory, Darin Kincaid, Jake Haley, Cassie Kleeman, and Jamie Clevenger. Also in attendance were Superintendent Mr. Daniel Street, Elementary Principal Tyna Morrison, Secondary Principal Chadwick Boyles, teachers Traci Heussner and Kaylyn Goodsell, and Bookkeeper/Business Manager Brooke Westcott. Board member Larry Shoe was absent.
