March 17, 2024

Regular Session

Board President Emily Davies called the meeting to order at 7:02 pm. Board members present were Emily Davies, Levi Mallory, Jake Haley, Cassie Kleeman, Darin Kincaid, Larry Shoe, and Jamie Clevenger. Also in attendance were Superintendent Mr. Daniel Street, Bookkeeper Brooke Westcott, Elementary Principal Tyna Morrison, Secondary Principal Chad Boyles, SpEd Director Nicole Kelly, and Athletic Director Angie Stone, as well as Elementary educators Katy Rogers, Erika Swindler, and Traci Heussner, Secondary educators Bailey O'Dell, Kaylyn Goodsell, and Kelly Lee, Root Ed advisor Becky O'Dell, Maintenance staff member Dalton Barnes, and community members Amanda Dunwoodie and Sharon Wright.

Larry Shoe made a motion to approve the agenda. Cassie Kleeman seconded the motion and all members voted yes.

Larry Shoe made a motion to approve the consent agenda, including previous Board Meeting minutes, financial statements and payment of bills, and the current substitute list. Cassie Kleeman seconded the motion and all members voted yes.

Becky O'Dell made a presentation to the Board regarding recruitment, retention, schedules, and collaboration.

Larry Shoe made a motion to accept the lawn mowing bid of Clay James for the 2025 season. Cassie Kleeman seconded the motion, and all members voted yes.

Larry Shoe made a motion to set the 2025-26 tuition rate at \$9,000 annually. Jamie Clevenger seconded the motion, and all members voted yes.

Jamie Clevenger made a motion to approve the Open Enrollment Opposition Resolution. Darin Kincaid seconded the motion and all members voted yes.

Policy review covered Section MCE 6000.
