Board President Emily Davies called the meeting to order at 7:00 pm. Board members present were Emily Davies, Darin Kincaid, Larry Shoe, Jake Haley, Cassie Kleeman, and Levi Mallory. Also in attendance were Superintendent Mr. Daniel Street, Elementary Principal Tyna Morrison, Secondary Principal Chadwick Boyles, Bookkeeper/Business Manager Brooke Westcott, and Teachers Mrs. Bailey O'Dell, Mrs. Kaylyn Goodsell, Ms. Michelle Haughton, and Ms. Taran Kelley. Band Director Kaleb Christman arrived at 7:04 pm. Board member Jamie Clevenger was absent.

Larry Shoe made a motion to approve the agenda. Cassie Kleeman seconded the motion and all present members voted yes.

Larry Shoe made a motion to approve the consent agenda, including previous Board Meeting minutes, financial statements and payment of bills, and the current substitute list. Cassie Kleeman seconded the motion and all present members voted yes.

The Board reviewed Administrative and the Superintendent's reports. The Board discussed the building's roof, and meetings scheduled to begin planning the repairs.
