- Rhetorical speaking techniques can extend beyond the written word (i.e. body language, eye contact, gestures, etc.).
- Rhetorical strategies are not exclusive to nonfiction writing. All writers apply such strategies in order to develop attitude, symbolism, and theme.
- The Great Depression challenged American mindsets and cast politicians in a negative light that President Roosevelt needed to re-shade, and one method by which he did so was speeches.
- Implicit meaning is often best interpreted once the purpose of the whole text is identified.
- Rhetorical strategies can be the difference between an unwieldy crowd and an attentive audience.
- Syntactical techniques can serve various purposes (e.g. varying pace, building momentum, establishing rhythm, mirroring content).
