## VIDE St. Croix District Announces 2025 Summer Food Service Program Mandatory Training Sessions for Site Supervisors

The Virgin Islands Department of Education (VIDE), St. Croix District, announces its mandatory training sessions for Summer Program Site Supervisors participating in the 2025 Summer Food Service Program (SFSP). The SFSP, which operates from June 9 through July 18, 2025, is dedicated to ensuring that children across the Territory receive nutritious meals throughout the summer months. All interested participants are required to attend one of the following in-person training sessions:

- Monday, May 12, 2025, from 2:00 pm 3:30 pm
- Thursday, May 22, 2025, from 2:00 pm 3:30 pm

To ensure seamless program operations, all campsites must have at least one representative present. It is highly encouraged that more than one person from each site attend the training to avoid disruptions during the summer program.
