New Business:

Suggested that PTA members go to their groups and ask what information they want presented at the event, so we can cover the topics to meet the community needs.

Review of By Laws and Amendments- The suggested amendments made to the bylaws at the last meeting were reviewed and a vote taken. Vote taken and in favor of accepting the amendments as written.

Fentanyl/ Narcan Committee- We had plans to attend the Parent University meeting that was dealing with vaping and Fentanyl. The meeting was cancelled due to ice. The committee was going to review the information and decide if more information needs to be available to our parents. We discussed how to get more people to attend these informational meetings. Suggestions are teacher newsletters, grade level newsletters at the elementary schools. Middle School and High Schools have a periodic newsletter that goes to the parents. Information on the programs can be included there. Record the sessions and parents can watch from home. A suggestion for childcare for parents to encourage more to attend. Stickers to go home with students regarding the program. Incentives from the teachers were other ideas for increasing attendance.

Good News- Impact Red Oak has donated \$100,000 for the renovation of the old Lion's Club facility that is used for the Red Oak Senior Citizen Center now.
