- 1.  - We ask for parent feedback while reviewing our PFE during our CAAC meetings.
 - Our plan is then distributed and shared on our website, during our CAAC meeting, and during out PTO meeting
- 2. Ruth Barron Elementary shall convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited & encouraged to attend, to inform parents of their school's participation in Title I & to explain the requirements of Title I, and the right of parents to be involved.

 - Parents are notified of the meeting via email/ Messenger, Facebook, and personal email
 - Gerardo Ortiz the principal will be conducting the meetings
- 3. Ruth Barron Elementaryshall offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, childcare, or home visits, as such services relate to parental involvement.

- We reach out to the community in a variety of ways. We have established CAAC
 meetings, established PTO meetings that occur at the school, established Coffee
 with Parent meetings, weekly meetings with parents who come in and to make
 appointments, weekly support meetings for parents.
- Our meetings occur in the evenings for parents to attend, as well as in the morning after parents drop off their students, and during school or right after school depending on parent needs.
- We assist families with walking students home if asked, we follow up with home visits to assist in needs that parents may come across. We also set up activities in the evening and during the day at our school to assist students and families.
- 4. Ruth Barron Elementary shall involve parents, in an organized, ongling, and timely way, in the planning, review, and improvement of programs including the planning, review, and improvement of the school parent & family engagement policy and the joint development of the campus improvement plan, except if the school has in place a process for involving parents in the joint planning & design of the school's programs, the school may use that process if such process includes an adequate representation of parents of participating children.
 - After the staff does our review of the CIP, we have a scheduled CAAC Meeting
 where we review and revise the CIP as well. In the presentation parents review
 every part of our CIP with us. Parents are allowed to ask questions and they give
 suggestions after seeing how the staff feel about the school's progress in
 meeting all the CIP goals. As part of CAAC we chose individuals from all parts of
 the school and the community to have fair representation of all parties.
- 5. Ruth Barron Elementary shall provide parents of participating children (A) timely information about programs; (B) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards; and (C) if requested by parents, opportunities for regular meetings to formulate suggestions & to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably able.
 - We provide Literacy Nights, Math Nights, Science Nights, and Word Cutture Nights.
 - We have monthly Coffee Talks with parents where we talk about specific concerns such as report cards and how to access report cards, state assessments, school curriculum, and where parents can make suggestions and give us insight on things we are not aware of.
 - In addition we host PTO meetings and PTO fundraisers such as the Fall Festival, and other activities arranged by the PTO.
 - Our report card is shared to the community via Skyward format. At this time we are ways to help the community to skyward and to possibly print report cards.

- 6. If the schoolwide program plan (the Campus Improvement Plan) is not satisfactory to the parents of participating children, the campus principal will submit any parent comments on the plan when the school submits its CIP to the district for review each September.
 - The CIP is shared with my CAAC committee after each schedule review by the teachers.
 In addition specific CIP plans that are related to Title 1 are also shared with the PTO and shared at our Family Open house at the beijing of the year
- 7. To ensure effective involvement of parents & to support a partnership among the school, parents, and community to improve student academic achievement, *Ruth Barron Elementary* shall:
 - (1) provide assistance to parents of children served by the school, as appropriate, in understanding such topics as the challenging State academic standards, State and local academic assessments, the requirements of this part, and how to monitor a child's progress and work with educators to improve the achievement of their children;
 - We reviewed the state standards with parents at our Open House, We reviewed upcoming assessments during Coffee the Parents, and we have our LPAC representative review services offered through LPAC. We advertised, and called parents to come in and show them how to sign up for Skyward, to allow them access to their child's grades.
 - (2) Provide materials & training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology to foster parental involvement.
 - We provided a Literacy Night at our school for families and we provided training on the computer. We helped parents set up emails and showed them how to access Skyward, and maneuver Skyward to access information for their children.
 - (3) Reach out to, communication with, work as equal, and implement & coordinate parent programs and build ties between parents and the school among teachers, specialized instructional support personnel, principals, and parents
 - We have set up our monthly Coffee talks with parents. This is set up intentionally
 and is coordinated by my Parent Liaison. I invite my counselor and Assistant
 participate as well. This is purposely set up to build relationships with these
 specific personnel as they are leadership positions and are personnel that
 communicate to parents many of the resources and information that parents
 need.

- (4) To the extent possible, coordinate & integrate parent involvement programs with other federal, state, and local programs, including preschool & conduct other activities such as parent resource centers that encourage parents in more fully participating in the education of their children.
 - My teachers have had a very symbiotic relationship with the PTO. The PTO has helped me coordinate teacher morale activities, such as luncheons during PD or breakfast and lunches during PD and during the year. In addition they provide delightful surprises such as making popcorn for staff, snow cones for staff, fruit bowls and elote. In addition my staff participate and volunteer in all PTO activities. In addition my staff have set up after school activities for students such as Soccer, Cursive, Green Club, Student Council, UIL, Math Pentathlon, Color Guard, and tutoring after school.
- (5) Provide such other reasonable support for parental involvement activities as parents may request.

English Class has been requested and a class to understand using Skyward. My parent liaison is making a questionnaire to find out what classes they would like offered.
