Mustang Stampede is BLHS's school-age child care program. Mustang Stampede is administered by the Community Education department of the Buffalo Lake-Hector-Stewart School District #2159.

What are we all about?

Mustang Stampede is a school age child care program for BLHS Students entering Kindergarten through age 12. We provide a safe, welcoming environment for the children. Children are able to participate in a variety of activities before and after school such as: crafts, reading, building, going outside, and using the gym when available. They are offered school breakfast in the morning and a snack in the afternoon.

Program Dates & Times

Starts: Monday, June 2, 2025 and goes through Friday, August 22, 2025.

Hours of Operation:

We are open from 6:30am-5:30pm Monday-Friday.

Location: BLHS School Cafeteria: enter through the bus loop door

Eligibility: Children entering Kindergarten in September of 2025 through age 12.

Registration & Cost

Weekly Rates: Mustang Stampede will be billed each week on Monday for the previous week. Payment will be automatically withdrawn weekly using the platform Brightwheel. Please make sure to set up your account once registered with the program.

Weekly Rates:

4-5 Days of Care: \$140

1-3 Days of Care: \$90

*In the event of an absence you will still be billed. If you know you are going to be gone, you must give a 2 week notice to not be billed for your hours.
