

SUBJECT: FY25 SCHOOL EFFECTIVENESS SURVEY (SEQ) RESULTS

The FY25 School Effectiveness Survey (SEQ) was administered from January 6 to March 3.^{1,2} The survey was administered online for students in grades 3 through 12, all school-based staff, and parents of students in grades Kindergarten through 12. In addition, a paper-based option was available for parents and students who were unable to complete the survey online. The results are provided on <u>an interactive dashboard</u> available via the Test/Survey Reports site.³ A high-level overview of findings is presented below.⁴

Participation:

To ensure the results accurately represent the views of stakeholders, a response rate of 80% is desirable. The FY25 participation was slightly lower than FY24. The student participation rate was 79% with 100,996 participants. Although this was down from 80% in FY24, it was up from 62% in FY23 and 25.2% in FY22. Staff participation was also slightly reduced in FY25 with 69% (14,873) of school-based staff participating this year, which was down from 73% in FY24 but up from 61% in FY23 and 43% in FY22. Parents increased participation to 21% (34,970) in FY25 from 19% in FY24, 16% in FY23, and 2.7% in FY22. The comparatively lower response rates among parents indicates that their data should be



viewed with caution. In FY25, The Districtwide response rate reached 80% or higher for students at 135

schools. The 80% or higher participation criterion was also met for staff at 77 schools and for parents at 3 schools.

Perceptions:

Each question on the student, staff, and parent surveys was accompanied by five response options from which participants could select to indicate their perspectives: *Strongly Agree, Somewhat Agree, Somewhat Disagree, Strongly Disagree,* and *N/A or I don't know.* Perceptions were summarized as the percent of participants who *Strongly* or *Somewhat Agreed* with each question, excluding those who selected *N/A or I don't know.* The figure displays the percent providing positive ratings overall and by topic area for the three respondent groups. Overall, staff provided the most favorable views (93.6%, up from 93.4% in FY24), followed by parents (89.3%, down from 90.0% in FY24) and students (82.5%, up from 80.8% in FY24). In FY25, Staff and parents tended to provide favorable ratings for each topic area (>90% and ≥86% for all topics, respectively). Students provided positive ratings for Family Involvement, School Effectiveness, Students Agency, and Safety (all >80%) in FY25. Although fewer students reported favorable views of Mental Health & Wellness (72.8%), the ratings demonstrate a 6.4% increase from FY23. A list of items comprising each topic is attached.

Further data show:

- Students have particular concern with the amount of respect that students have for each other at school (65.5%); however, this rating demonstrates a 12.5% increase from 2023. Students also showed concern over being treated with respect by adults at school (71.5%, down from 75.2% in FY24 and 76.1% in FY23).
- Mental Health & Wellness is still a concern for students across most schools and grade levels but the
 perceptions are trending in a positive direction.

- Overall variability in perceptions across racial groups was limited to 4.5 percentage points in FY25, ranging from 78.5% among Black students to 83.0% among Asian students.
- English Language Learners (ELLs) had the most favorable perceptions at 84.4% positive ratings.
- The item "Students respect each other at this school" was a concern across all demographic groups.
- Overall, non-instructional staff tended to provide more favorable ratings than did instructional.

Schools, Principal Supervisors, and District departments are encouraged to explore the interactive <u>SEQ</u> <u>Results Dashboard</u>. The following questions are offered as guides for exploration:

- 1. Did participation meet 80% for all participant groups? If not, how can participation be improved?
- 2. In what areas did participants indicate that we are doing well?
- 3. In what areas did participants indicate concern?
- 4. How can these data be used to make improvements for the remainder of FY25?
- 5. How do these data inform planning for FY26?
