Required Documents for Registration

All documents can be directly uploaded to Cambrian's online registration system.

- Proof of Age:** An original Certified Birth Certificate, Birth Record, Baptism Certificate, or Passport with a parent/guardian photo ID. *(required)*
- Proof of Immunizations:** Your child's yellow immunization card or a printout from your physician, clinic, or previous school. All required immunizations must be met prior to school starting. If all required immunizations are not met, your child will not be able to attend school. *(required)*
- Proof of Tuberculosis Skin Test or Tuberculosis Risk Assessment:** The Santa Clara County Public Health Department requires proof of a Tuberculosis (TB) skin test or a completed TB Risk Assessment Form prior to school entry.
 - Immunization record and must include the test date and results.
 - If there is no proof of a TB skin test on record, a TB Risk Assessment Form must be completed by a licensed healthcare provider in the United States. Or you may contact our District Nurse for more information.
- Proof of Residency:** The Cambrian School District requires two (2) forms of address verification for all students: ONE (1) document from List A and ONE (1) document from List B. *Both documents must include the name of the parent/guardian and the current residential address. (required)*
 - If you reside outside the Cambrian School District boundaries and are requesting Bagby or Steindorf, you must include an approved Interdistrict Transfer Request Form from your district of residence with your registration.
 - If you have recently moved into the Cambrian School District, you must provide one document from List A to complete your registration. You will have 30 days from the registration date to submit the second document from List B.

Please note: Cambrian School District reserves the right to make home visits in order to verify residence at any time. Falsification of any information or documents required for residency verification or the use of the address of another person without actually residing there may result in the immediate revocation of student enrollment (Cambrian School District Board Policy 5111.1).

- 1st through 8th grade Students:** Most recent report card. *(optional)*
- Special Education Students:** A signed copy of the most current IEP or 504 plans must be uploaded to Cambrian's online registration system. *(required)*
- TK Students & Kindergarten Students:** Additional required form below:
 - An Oral Health Assessment: California requires your child to have a dental check-up by **May 31** of their first year in public school. (Educational Code Section 49452.8)
