

Riverside Minutes  
Reorganization Meeting

December 6, 2021  
Riverside Jr-Sr High School

The Reorganization Meeting of the Riverside School Board was held on the above date at 7:00 p.m. in the Riverside Jr-Sr High School with Linda Joyce presiding and the following members present: Caryn Emiliani, Kevin Harchar, and Mary Antoniaci McHugh.

Also present were Superintendent Paul M. Brennan and Attorney Raymond C. Rinaldi, II.

Motion to adjourn sine die. YES, Joyce, Emiliani, Harchar, and Antoniaci McHugh.

Motion by Ms. Emiliani, seconded by Mr. Harchar pursuant to Section 402 of the PA School Code of 1949 to appoint Linda Joyce, a hold-over Board Member, as President Pro-Tempore of the 6 December 2021 organizational meeting of the Board of Directors of the Riverside School District. Roll call vote: YES, Joyce, Emiliani, Harchar, and Antoniaci McHugh.

Linda Joyce assumed the chair as President Pro-Tempore.

President Pro-Tempore, Linda Joyce, as pursuant to Section 402 of the School Code called for the presentation of certificates of election by all persons claiming to have been duly elected at the 2021 General Election held on November 2, 2021, namely Carol Armstrong, Barbara Fedor, Tara Meredick, and Dan Nenish.

Pursuant to and as required by Section 402 of the School Code, the Secretary reads aloud each certificate of election as per the attached. The oath of office required by Section 321 of the School Code was administered by Magisterial District Judge George E. Seig.

Motion pursuant to Section 402 and Section 433 of the School Code of 1949 to approve and accept the attached "Certified list of legally elected and duly qualified school directors of the Riverside School District" as presently constituted, and to instruct the Secretary to attach a certified copy thereof to the official minutes.

Motion by Mrs. Meredick, seconded by Mrs. Fedor pursuant to Section 404 of the School Code of 1949 to nominate and elect Carol Armstrong as President of the Board of Directors of the Riverside School District for a one (1) year term. Roll call vote: YES, Joyce, Emiliani, Harchar, Antoniaci McHugh, Meredick, Nenish, and Fedor. ABSTAIN, Armstrong. MOTION CARRIED.

Mrs. Armstrong assumed the chair as President.

Motion by Mrs. Meredick, seconded by Ms. Mary Antoniaci McHugh pursuant to Section 404 of the PA School Code of 1949 to nominate and elect Linda Joyce as Vice-President of the Board of Directors of the Riverside School District for a one (1) year term. Roll call vote: YES, Emiliani, Harchar, Antoniaci McHugh, Meredick, Nenish, Fedor, and Armstrong. Abstain, Joyce. MOTION CARRIED.

Motion by Mr. Harchar, seconded by Mrs. Meredick pursuant to Section 406 of the PA School Code of 1949 to appoint Raymond C. Rinaldi, II as District Solicitor for a period of one (1) year and to authorize the officers of the Board to execute a contract of employment with the duly appointed Solicitor at a retainer of \$9,000. Roll call vote: YES, Joyce, Emiliani, Harchar, Antoniaci McHugh, Meredick, Nenish, Fedor, and Armstrong.

Motion by Mr. Harchar, seconded by Mrs. Meredick pursuant to Section 421 of the PA School Code of 1949 to establish the following 2022 School Board Meeting Schedule:
