Reorganization Meeting

December 6, 2017  
Riverside Jr-Sr High School

The Reorganization Meeting of the Riverside School Board was held on the above date at 6:00 p.m. in the Riverside Jr-Sr High School with Atty. Raymond C. Rinaldi, II presiding and the following members present: George Bieber, Caryn Emiliani, Linda Joyce, and Mary Antoniaci McHugh. Absent: Charles Maurer, Jr.

Also present were Superintendent Paul M. Brennan, Mr. Joseph Surridge, and Attorney Raymond C. Rinaldi, II.

Motion to adjourn sine die. YES, Bieber, Emiliani, Joyce, Antoniaci McHugh.

Motion by Mr. Bieber, seconded by Ms. Emiliani pursuant to Section 402 of the PA School Code of 1949 to appoint Linda Joyce, a hold-over Board Member, as President Pro-Tempore of the 6 December 2017 organizational meeting of the Board of Directors of the Riverside School District. Roll call vote: YES, Bieber, Emiliani, Joyce, Antoniaci McHugh.

Linda Joyce assumed the chair as President Pro-Tempore.

President Pro-Tempore, Linda Joyce, as pursuant to Section 402 of the School Code called for the presentation of certificates of election by all persons claiming to have been duly elected at the 2017 General Election held on November 7, 2017, namely Carol Armstrong, Barbara Fedor, Tara Meredith, and Dan Nenish. Pursuant to and as required by Section 402 of the School Code, the Secretary reads aloud each certificate of election as per the attached. The oath of office required by Section 321 of the School Code was administered by Judge Julia Munley.

Motion by Mr. Nenish, seconded by Mrs. Fedor pursuant to Section 402 and Section 433 of the School Code of 1949 to approve and accept the attached "Certified list of legally elected and duly qualified school directors of the Riverside School District" as presently constituted, and to instruct the Secretary to attach a certified copy thereof to the official minutes.

Motion by Mrs. Fedor, seconded by Ms. Antoniaci McHugh pursuant to Section 404 of the School Code of 1949 to nominate and elect Carol Armstrong as President of the Board of Directors of the Riverside School District for a one (1) year term. Roll call vote: YES, Bieber, Emiliani, Joyce, Antoniaci McHugh, Armstrong, Fedor, Meredick, Nenish.

Mrs. Armstrong assumed the chair as President.

Motion by Mrs. Fedor, seconded by Mr. pursuant to Section 404 of the PA School Code of 1949 to nominate and elect Linda Joyce as Vice-President of the Board of Directors of the Riverside School District for a one (1) year term. Roll call vote: YES, Bieber, Emiliani, Joyce, Antoniaci McHugh, Armstrong, Fedor, Meredick, Nenish.

Motion by Mrs. Joyce, seconded by Ms. Antoniaci McHugh pursuant to Section 404 of the PA School Code of 1949 to nominate and elect Barbara Fedor as Secretary of the Board of Directors of the Riverside School District for a one (1) year term. Roll call vote: YES, Bieber, Emiliani, Joyce, Antoniaci McHugh, Armstrong, Fedor, Meredick, Nenish.

Motion by Ms. Emiliani, seconded by Mrs. Fedor pursuant to Section 404 of the PA School Code of 1949 to nominate and elect George Bieber as Treasurer of the Board of Directors of the Riverside School District for a one (1) year term. Roll call vote: YES, Bieber, Emiliani, Joyce, Antoniaci McHugh, Armstrong, Fedor, Meredick, Nenish.

Motion by Mr. Bieber, seconded by Mrs. Fedor pursuant to Section 406 of the PA School Code of 1949 to appoint Raymond C. Rinaldi, II as District Solicitor for a period of one (1) year and to authorize the officers of the Board to execute a contract of employment with the duly appointed Solicitor at a retainer of \$9,000. Roll call vote: YES, Bieber, Emiliani, Joyce, Antoniaci McHugh, Armstrong, Fedor, Meredick, Nenish.

Motion by Mrs. Joyce, seconded by Mr. Bieber pursuant to Section 421 of the PA School Code of 1949 to establish the second Monday of each month at 7:00 p.m. as the regular date and time for the regular meetings of the Board of Directors of the Riverside School District. The Public Work Sessions will be held on the first Monday of each month at 7:00 p.m. with any closed executive meeting required to take place prior to regularly scheduled meeting/work session or the call of the chair; provided that the Superintendent of Schools for the Riverside School District gives public and advertised notice thereof as required by law. Committee Meetings will be held on the third Monday of each month at 7:00 p.m. All meetings will be held at the Riverside Jr-Sr High School Library. Roll call vote: All in favor.

Motion by Mr. Bieber, seconded by Ms. Antoniaci McHugh to adjourn organizational meeting.
