With Regard to Updated CDC Mask Guidance Announced on Thursday 05/13

The CDC has announced that vaccinated individuals do not need to wear a mask while indoors or outdoors. This is GREAT news for our country! However, please remember we follow NJ Department of Health Guidance, not CDC. As of this writing, nothing changes in New Jersey Schools or RLC. I will update the community if this guidance in New Jersey changes.

With Regard to Field Day

We are excited to bring back Field Day this year! May 28th, will be Field Day! It is a 1pm Dismissal. We have organized a day that ensures Covid-19 mitigation procedures are followed and the students have a great time! With Regard to Live Students Attending Daily Live Instruction

As we continue to increase our Live Student Attendance, we are also seeing students/families choosing to stay remote on individual days, without Office Approval. Please remember, that if your child is a LIVE student, the expectation is that he/she is in school, unless approved by the Office Staff, Nurse Gallo, or MyMedBot. Teachers need to be notified of Daily Remote approvals so that we can appropriately prepare instruction and student work. If we don't approve these daily changes and communicate them with teachers, it makes it very challenging on our teachers. Thank you for your continued support and communication of your family needs.
