

## GENERAL COMMITTEE REPORT

### TUESDAY, JUNE 13, 2017

The St. Bernard Parish School Board met as a Committee of the Whole on Tuesday, June 13, 2017 at 6:00 p.m. in the Board Room of the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Present were, Mrs. Diana B. Dysart, President, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Mr. William H. Egan, Mr. Carl W. Gaines, Jr., Mr. Clifford M. Englande, Mrs. Katherine K. Lemoine, Mr. Joseph V. Long, Sr., and Mr. Sean K. Warner. Dr. Hugh C. Craft and Dr. Henderson Lewis, Jr. were absent.

Mrs. Dysart welcomed Mr. Jason Brown of the St. Bernard Voice to the meeting.

Mrs. Dysart next welcomed Ms. Alex Schneider to present the June 2017 edition of Super News. She began by highlighting a few upcoming events such as the Performing Arts Academy production of “The Little Mermaid” which will run from June 22<sup>nd</sup> through July 2<sup>nd</sup> at the CHS Cultural Arts Center and the Maumus Center Planetarium public showings which are scheduled throughout June and July.

Ms. Schneider next proceeded to topics within the Super News Video. The topics covered this month included CHS Graduation, Kindergarten, 5<sup>th</sup> Grade and 8<sup>th</sup> Grade exit ceremonies, Coroner Reading and Writing awards presentation, Summer swim lessons, The Little Mermaid production, Methodist School Based Health Center Clinic 10 Year Anniversary, School Board Financial Reporting Awards for Excellence, Special Olympics State Olympic participation and recognition as a Program of Distinction, Smith Elementary Beta Club heads to Disney World for the National Beta Competition, Academic Games Nationals participants head to Wheeling, West Virginia to compete and Teacher Features on Michelle Foland of Rowley Alternative, Tiffani Glapion Assistant Principal at Davies Elementary, Melissa Collins of Lacoste Elementary School, Beverly Brumfield also of Lacoste Elementary, Jodi Crifasi of Smith Elementary School and Kailyn Lotz of Arabi Elementary School. The last bit of info announced the Maumus Center Planetarium shows for the summer.

Dr. Craft arrived at the meeting during the Super News presentation.

Mrs. Dysart thanked Ms. Schneider, Barry Lemoine and Jack Jackson for their Super News production.

Mrs. Dysart turned the meeting over to Mr. Gaines as the Education Committee Chair and he welcomed Mr. Conrad Browne, Technology Coordinator, to update the Board on Erate and Technology in the School System.

Regarding Erate, Mr. Browne explained that this is a federal program that is available for schools and libraries who can received a discount on your telecommunications bills based upon your free and reduced lunch population with 90% being the maximum that can be covered by Erate. The information shown below was presented to the Board.

  - Replaced 60 Teacher Laptops
- This Summer:
  - Projectors at Arabi, Chalmette Elementary, Lacoste and Gauthier
  - Wireless upgrade at all Elementary Schools and Rowley
  - Replace 75 Teacher Laptops
- 2500 Chromebooks on order for the new school year:
  - 1 Cart Every 5<sup>th</sup> Grade Class
  - 1 Cart Every 6-8 ELA, Science and Social Studies classrooms
  - 1 Cart Every EOC classroom
- June 1 and June 2, 28 teacher leaders received Google Level 1 training
- Week of June 5, 28 teachers took the exam to become Google Level 1 certified. Long term goal is to complete Level 2 certification then the trainer certification. This would allow these 28 leaders to be Google Certified to train others.

After all questions were addressed, Mr. Gaines thanked Mr. Brown for his Erate and Technology Review.

Dr. Craft continued with Executive Committee business and invited Mr.

Granberry to share the Personnel Changes for June 2017. Mrs. Dysart and Mr. Gaines congratulated retiree Elizabeth Lauga from Chalmette Elementary and thanked her for her years of service. Dr. Craft thanked Mr. Granberry for the information.

As Finance Committee Chair, Mr. Englande welcomed Dr. Charles Raviotta, Curriculum Supervisor, to present a request to approve the Head Start request for expenditure of a COLA increase. Dr. Raviotta explained that a notice was received regarding a Head Start COLA increase of \$8,301.00 which he is requesting to dedicate toward supplies.

Dr. Craft moved to approve the Head Start request for expenditure of the \$8,301.00 COLA increase on supplies. Seconded by Mr. Warner, the motion passed unanimously by a roll call vote of the members present.

Mr. Englande then welcomed Mr. Fernandez to discuss the Official Journal bid tabulation. The only proposal was from the St. Bernard Voice at the cost of \$2.94 per columnar inch and \$2.94 per square to publish all minutes and public notices. Mr. Fernandez stated that the Administration recommends the St. Bernard Voice as its Official Journal.

Mrs. Dysart moved to recommend to the Board to accept the proposal of the St. Bernard Voice as the School Board's Official Journal for the fiscal year 2017-2018. Seconded by Mr. Long, the motion passed by a roll call vote of the members present with no objections.

Mr. Fernandez next presented the tabulation of bids for Vehicle painting and body repairs for July 1, 2017 through June 30, 2018. Two bids were submitted. The Administration recommends the low bidder – Car Craft Inc.

On motion of Mr. Gaines and seconded by Mrs. Asevedo, the Committee voted by a unanimous roll call vote of the members present to recommend to the Board to accept the Administration's recommendation of Car Craft as the provider of Vehicle painting and body repairs for School Board vehicles for July 1, 2017 through June 30, 2018.

Mr. Fernandez next presented the Committee with the tabulation of bids for gasoline, diesel, lubricating oil, antifreeze and transmission fluid for the fiscal year July 1, 2017 – June 30, 2018. Mr. Fernandez stated that FleetCor was the low bidder for both gasoline and diesel fuel and therefore was the Administration's recommendation. Mr. Fernandez noted that for lubricating oil the award goes to Davison Oil based on their bulk price of 825 gallons and the price of a single 55 gallon drum. For Anti-freeze the Administration recommended Safety Kleen with a low bid of \$5.33 per gallon and \$293.00 per 55 gallon drum. As the low bidder for transmission fluid, Safety Kleen was the low bidder with a price of \$10.48 per gallon and \$576.24 per 55 gallon drum.

Dr. Craft moved to recommend to the Board to accept the recommendation by the Administration to have the low bidders; Fleetcor provide gasoline and diesel, Davison Oil provide lubricating oil, Safety Kleen provide antifreeze and transmission fluid for the fiscal year of July 1, 2017 through June 30, 2018. Seconded by Mr. Warner, the motion passed by a unanimous roll call vote of the members present.

Mr. Fernandez next presented the bid tabulation for paper, cleaning and custodial supplies. He stated that the Administration recommend accepting the lowest responsive bidder in each category.

With a motion by Mr. Warner and seconded by Mrs. Dysart, the Committee voted unanimously by a roll call vote of the members present to recommend to the Board to approve the lowest responsive bidder in each category of the paper, cleaning and custodial product bid tabulation.

Under Superintendent Recommendations Ms. Voitier noted that at the June 27<sup>th</sup> meeting the Administration is going to ask the Board to announce that at the August 22<sup>nd</sup> meeting the Board consider adopting a resolution ordering the call of an election to be held on November 18, 2017 for the purpose of renewing currently levied operational millages. She also noted that she was so pleased with the summer offerings of the Swim Lessons, Summer Skills, the Planetarium shows, athletic programs and the stage production of Little Mermaid which enrich the lives of the children in the parish and also professional development offered for employees.

On motion of Mr. Campbell, seconded by Mrs. Asevedo and passed by a unanimous voice vote, the meeting was adjourned.

Mrs. Dysart next welcomed Ms. Voitier to present the June 2017 Personnel changes. Mrs. Dysart congratulated Elizabeth Lauga on her retirement and thanked her for her years of service.
