

REGULAR MONTHLY MEETING
MAY 23, 2017

The St. Bernard Parish School Board met in a Regular Monthly Meeting on Tuesday, May 23, 2017 at 6:00 p.m. in the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Present were Mrs. Diana B. Dysart, President, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Dr. Hugh C. Craft, Mr. William H. Egan, Mr. Carl W. Gaines, Jr., Mr. Clifford M. Englande, Mr. Joseph V. Long, Sr., and Mr. Sean K. Warner. Mrs. Katherine K. Lemoine and Dr. Henderson Lewis, Jr., were absent.

The public hearing for the 2017-2018 General Fund and Special Revenue Funds budgets was held. No one appeared to address the Board at the public hearing.

No one wished to address the Board under Community Concerns.

At this time, Mrs. Dysart welcomed Mr. Paul Frey, Special Education Teacher, to the meeting to recognize the state Special Olympics participants. Mr. Frey explained that the state Special Olympics took place on May 19-21, 2017 at Southeastern Louisiana University. Mr. Frey also noted that the team brought home 53 Awards which include, 17 gold medals, 18 silver medals, 5 bronze medals, 11 - 4th place winners, 2 - 5th place winners. Each participant was given a proclamation from the Board in recognition of their outstanding performances at the State games.

Mrs. Dysart thanked and congratulated all the students, parents, coaches and supporters for attending the meeting. Ms. Voitier thanked the whole community for their assistance in making our local Special Olympics and Special Education Program so successful. A brief recess was taken for photographs.

Mrs. Dysart announced the next agenda item, the recognition of the National Academic Games Team. Academic Games Coordinator, Mary Lumetta, began the presentation by applauding team members and showing the trophies they won to the Board. She then expressed her gratitude to the parents, coaches and especially Chalmette Refinery – PBF Energy for their generosity in sponsoring the team's trip to the national tournament as well as the awards for local tournaments and shirts for the team.

All the coaches and team members received proclamations from the President of the Board, Mrs. Diana Dysart, for their outstanding achievements at the 2017 Academic Games National Competition in Wheeling, West Virginia.

The Middle Division Team was coached by Ms. Gena Asevado and as a team received 9th Place out of 42 teams in the Presidents competition. An individual award for 13th place was received in Presidents also.

Members of the Middle Division Team are; Ethan Gilchrist, Brandon Jackson, Jedelle Lafuente, Landin Sanborn and Anthony Wei who placed 13th in Presidents.

The Coach for the Elementary Academic Games National Team, Melinda Hall, was honored for her success in training her team. As a team they received a 2nd place in Presidents and 5th place in Propaganda. There were also individual awards for 11th place and a 14th Place in Presidents and a 13th place Propaganda.

Members of the Elementary Division Team are; Colby Gilchrist, Selina Li who placed 14th in Presidents, Ava Volante who placed 11th in Presidents and 13th in Propaganda, Anthony Wei and Tania White.

The two (2) Senior Division Teams were coached by Jillian Chrisman and Leigh Peterson. As a team the Seniors received a 2nd place in Onsets and 4th place in Presidents.

A proclamation was also awarded to attorney Ryan Gregoire recognizing his contribution as a coach to the 2017 Academic Games National Team.

The President of the Board also awarded Ms. Mary Lumetta a proclamation for her dedication as an administrator of the Academic Games Program.

Members of the Board thanked the Parents, students and Coaches for their hard work and all their accomplishments. Chalmette Refining-PBF Energy was also applauded for their financial contribution. A brief break was taken for photos of the Board with the Academic Games participants.

Mrs. Dysart next welcomed employees of the Chalmette High School based Health Center. Mrs. Dysart read a proclamation congratulating the Health Center for their 10 years of service at Chalmette High School.

By joint acclamation, the Board adopted the following proclamation to be presented to the Health Center leaders.

Proclamation

Whereas Chalmette High School's School-based Health Center is an integral part of the school's mission to address at the great extent possible the academic, social, emotional, and physical needs of the students attending Chalmette High School; and

Whereas the Center continues to provide a necessary service to parish adolescents, the most underserved population in the medical field, at an average rate of over 50 students per day, one of the highest daily patient care averages in the state; and

Whereas the Methodist Health Systems Foundation, through the Center, serves our students by providing the highest standard of quality medical care to them and honors its mission of contributing to the overall health care of the citizens of St. Bernard Parish; now be it therefore

Resolved that the St. Bernard Parish School Board recognizes the staff and administrators of the Chalmette High School School-based Health

Center and the Methodist Health Systems Foundation for a 10-year commitment as a major partner in the services provided to students in St. Bernard Parish; and be it further

Resolved that the St. Bernard Parish School Board recognizes the staff and administrators of the Center and administrators of the Methodist Health System Foundations as honored members of our public school family for their continuing contributions and dedication to securing excellence in educational opportunities for the students of Chalmette High School.

Ms. Wendy Barron of the Methodist Health System Foundation spoke on behalf of the Health Center. She presented the Board with a small acrylic keepsake as a token of the Foundation's appreciation for all of the support the Health Center has received from the school system. Ms. Barron lauded the successful partnership between the Foundation and the School System and congratulated the Health Center team of one medical director, three nurse practitioners, a counselor, a social worker, two RN's, a medical assistant, a dietician and a center coordinator. Accolades include being named a Premier School Based Health Center in our state along with re-certification of the center for three more years. Ms. Barron was very proud to report that services have been provided to over 13,000 students with 68,427 visits.

Mr. Warner, Principal of Chalmette High School, noted that the Health Center has become an important and integral part of Chalmette High with a welcoming culture that benefits students and staff. Ms. Voitier also commented about the inception of the Health Center concept while foreign to her seemed to be a perfect fit for the rebuilding of the schools and the parish and with many partners like the Lions Club and the Methodist Health System Foundation these partnerships have been proven to be extremely successful.

After all members of the Board expressed their thoughts, Mrs. Dysart thanked both the employees and representatives of the Chalmette High School Based Health Center for their appearance tonight and special thanks went to Mr. Warner for also appearing and supporting the Health Center.

Next, Mrs. Dysart welcomed representatives from Entergy to consider their request for a right of way and use of unused School Board property in Arabi. Representing Entergy were Curtis Navis, Operation Coordinator for Entergy, Erin Kitchen, Project Manager for the proposed project to relocate their substation to the School Board Property, Pam Pervos, St. Bernard Customer Service Representative, Ryan Adams, Distribution Design Engineer and Toni Green Brown, public affairs manager.

Mr. Curtis Navis explained that the proposal involves the relocation of a Entergy sub-station that now exists outside of the levee at the end of Center St. in Arabi to a newly constructed sub-station at the end of Angela St. on School Board Property inside the protection levee which used to house the Drivers Education Driving Range. To do this, Mr. Navis stated that the proposed site would require the School Board to grant Entergy the rights to an exclusive servitude on this site. Paperwork handed out to the Board Members showed two possible site arrangements which had two different access roads to the sub-station. He also stated that the sub-station would be surrounded by a brick wall to contain any noise from the station with a minimum of traffic visiting the station on a regular basis. He also assured that during the construction, all vehicles for the construction would enter from Florida Ave. in the hopes of not disrupting local neighborhoods. Mr. Navis closed by stating that this new state of the art sub-station would give superior performance to St. Bernard Parish and provide easy access to technicians during electrical loss during storms.

Ms. Voitier asked about a previous meeting which ended with Entergy accepting responsibility to prepare a specific site plan with the placement of the sub-station and where exactly the roads would be placed which would show exactly the space that is being requested for this exclusive servitude. Ms. Voitier noted that the information provided to the Board tonight did not show the specifics of the sub-station site. Ms. Voitier asked that this information be assembled and presented to the Board before any consideration of the project.

After all questions and concerns were addressed by Entergy, Mrs. Dysart told the Entergy Representatives they are welcomed back when the appropriate site plan is prepared and ready for presentation.

Next, Mrs. Dysart invited Mr. David Fernandez to appear for recognition of the School Board receiving both the GFOA (Government Finance Officers Association) and ASBO (Association of School Business Officials) Certificate of Achievement for excellence in financial reporting. Mr. Fernandez acknowledged that the school system has achieved this honor over 23 years which Mr. Fernandez stated could not be done without his incredible staff in the business office. Mrs. Dysart and Ms. Voitier commended the employees responsible for these awards which assure the public that the school system is being responsible with public funds.

Dr. Craft proposed a commendation and resolution for the excellence in Financial Reporting by the St. Bernard Parish School Board Financial Team. By joint acclamation the Board approved the proposal for a commendation and resolution for the St. Bernard Parish School Board Financial Team for their excellence in Financial Reporting.

On motion of Mr. Warner, seconded by Mr. Long, the Board voted with no objections by a roll call vote of the members present to incorporate the report of the May 9, 2017 General Committee Meeting into the minutes of the May Regular Monthly Meeting.

GENERAL COMMITTEE REPORT TUESDAY, MAY 9, 2017

The St. Bernard Parish School Board met as a Committee of the Whole on Tuesday, May 9, 2017 at 6:00 p.m. in the Board Room of the St. Bernard Parish School Board Office. Following the Prayer and Pledge of Allegiance, the Secretary called the roll. Present were, Mrs. Darleen P. Asevedo, Mr. Donald D. Campbell, Dr. Hugh C. Craft, Mr. William H. Egan, Mr. Carl W. Gaines, Jr., Mrs. Katherine K. Lemoine, Mr. Joseph V. Long, Sr. and Mr. Sean K. Warner. Mrs. Diana B. Dysart, Mr. Clifford M. Englande and Dr. Henderson Lewis, Jr. were absent.

Dr. Craft, acting as chair for this meeting in Mrs. Dysart's absence, welcomed Ms. Alex Schneider with this month's Super News. Ms. Schneider began by presenting a few reminders of upcoming activities such as Day at the Capital to be held on Wednesday, May 10th, Chalmette High School Graduation on Thursday, May 11th and Elementary and Middle School exit programs which will occur on varying dates and times. In the Super News video, the events of the previous month were highlighted, events such as, The Annual Lions Club Golf Tournament, Golden Owls presentation for outstanding Chalmette High School Seniors presented at the annual Senior Awards night along with many other awards and scholarships for nearly 80 CHS seniors, The Top Chef Career and Technical Education student showcase, AdvancEd Certification visit, Celebrating our School Community banquet, Chalmette High School Honors banquet, Teacher Features highlighted Lori Norrell of Davies Elementary, Shellie Monk, Assistant Principal of Gauthier Elementary, Odile Campbell of W. Smith Elementary, Debbie Babin of Chalmette High and Assistant Superintendent and soon to be retiree, Mrs. Beverly Lawrason. Dr. Craft thanked Mrs. Schneider for her presentation.

Dr. Craft, on a point of privilege, mentioned his recent hospital stay and then congratulated the school district on its successful accreditation by AdvancEd. He also mentioned his attendance at the National School Board Association as the President of the Louisiana School Board Association where he heard Scott Kelly speak. Mr. Kelly impressed Dr. Craft because he was not always a super student but he did succeed as an astronaut. Dr. Craft did some research on Mr. Kelly as a high school student and found that he attended a high school that afforded Mr. Kelly both a high teacher to student ratio and a very low free and reduced lunch ratio. Dr. Craft noted that with our teacher to student ratio and our high

free and reduced lunch rate, the school district does an outstanding job in providing avenues of success for our students.

Mr. Gaines as Education Committee Chair welcomed Mr. Tommie Powell, Supervisor of Child Welfare and Attendance, to review changes to the Guide to Student Conduct.

Mr. Powell presented the changes to the Guide to Student Conduct for the 2017-2018 school year. He addressed all the questions and concerns the committee had regarding these changes.

Dr. Henderson Lewis, Jr. entered the School Board meeting during this agenda item.

Mr. Warner moved to recommend to the Board to approve the changes to the Guide to Student Conduct for the 2017 -2018 school year as presented by Mr. Powell. Seconded by Mrs. Asevedo, the motion passed with no objections by a roll call vote of the members present.

The next item on the agenda was addressed by Mr. Long as Executive Committee co-chair. Mr. Granberry presented to the Committee the Personnel Changes for May 2017.

Mr. Granberry next presented the Committee with the 2017-2018 Personnel Appointments. Mr. Granberry addressed all questions of the Committee.

Mr. Granberry next presented the Personnel Evaluation Plan with a recommendation for no changes at this time. Dr. Craft moved to accept the

Personnel Evaluation Plan as presented tonight with no changes.

Seconded

by Mrs. Lemoine the motion passed with no objections by a roll call vote of the members present.

Mr. Granberry again addressed the Committee with a request to mail Letters of Assurance for substitutes for the 2017-2018 school year. All questions or comments from the Committee were handled by Mr. Granberry.

Mr. Campbell made the motion to recommend to the Board to authorize the Administration to mail the Letters of Assurance. The motion was seconded by Dr. Lewis and passed by a unanimous roll call vote of the members present.

Mr. Long next handed the meeting over to the Insurance Committee Chair, Mr. William Egan. He welcomed Mr. David Fernandez, Finance Manager and Mr. Timothy Clements, our agent of record from Clements Insurance, to present the Administration's request for permission to renew flood insurance. Mr. Fernandez presented the worksheet that indicated the prices for each building for the flood insurance stating that the St.

Bernard School board is required to maintain maximum flood insurance available from the National Flood Insurance Program on all buildings.

A motion was made by Dr. Craft to recommend to the Board to accept the Administrations recommendation regarding flood insurance coverage for 12 months beginning May 31, 2017. Seconded by Mr. Campbell, the motion passed unanimously by a roll call vote of the members present.

Mrs. Lemoine as Finance Committee chair next introduced Mr. Fernandez to present the next agenda item regarding the adoption of 2017 Ad Valorem Millages. Mr. Fernandez stated that no increase in millages occurred but one of the millages to be adopted has been re-dedicated to the maintenance of buildings as was voted by the residents of St. Bernard Parish.

Mr. Warner moved to approve the Administration's recommendation to adopt the 2017 Ad Valorem Millages as presented. Seconded by Mrs. Asevedo, the motion passed unopposed by a roll call vote of the members present.

Mr. Fernandez next presented the Proposed Budgets for the 2017-2018 General Fund and Special Revenue Funds. Mr. Fernandez went over each of the highlights of the proposed General Fund and Special Revenue Funds budgets and answered all the Committee's questions.

A motion was made by Dr. Craft to recommend to the Board to approve the 2017-2018 General Fund and Special Revenue Funds budgets. The motion was seconded by Mr. Campbell and passed unanimously by a roll call vote of the members present.

The next agenda item was also addressed by Mr. Fernandez regarding the bid tabulation for the purchase of new buses. The bid tabulation shows that from the two (2) vendors who bid, Kent-Mitchell was the lowest bidder for the eight (8) new buses to be purchased. Mr. Fernandez stated that the Administration recommends the purchase be made from Kent-Mitchell.

With a motion from Mrs. Asevedo and a second by Dr. Craft, the Committee voted by a unanimous roll call vote of the members present to recommend that the Board accept the low bid from Kent-Mitchell for the purchase of eight (8) new school buses.

Mrs. Lemoine continued with Mrs. Joni Blum, Manager of School Food Services, to present the bid tabulation for Spices and Seasonings (Class 2) Cereal, Dried Beans and Crackers (Class 3), Frozen Foods (Class 5), Meat and Meat products (Class 6), Poultry and Eggs (Class 7), Seafood Products (Class 8) and Canned Goods (Class 9) for the period of July 1, 2017 through December 31, 2017. Mrs. Blum stated that the Administration recommends the low bid for each item as indicated on the spreadsheet given to the Committee members.

With a motion from Dr. Lewis, seconded by Mr. Long, the Committee

voted unanimously by a roll call vote of the members present to recommend to the Board to approve the Administration's recommendation of going with the low bidder as indicated on the spreadsheet of bids received for Spices and Seasonings (Class 2) Cereal, Dried Beans and Crackers (Class 3), Frozen Foods (Class 5), Meat and Meat products (Class 6), Poultry and Eggs (Class 7), Seafood Products (Class 8) and Canned Goods (Class 9) for the period of July 1, 2017 through December 31, 2017.

Next Mrs. Lemoine allowed Mrs. Blum to present the Administration's request to approve the bid tabulation for Milk and Milk products for July 1, 2017 through June 30, 2018.

With a motion by Mr. Long, seconded by Mr. Warner, the motion passed unanimously by a roll call vote of the members present to recommend to the Board to approve the low bidder on the bid tabulation for Milk and Milk products for July 1, 2017 through June 30, 2018.

Mrs. Lemoine next allowed Mrs. Blum to present the Administration's request to approve the bid tabulation for Bread and Bread products for July 1, 2017 through June 30, 2018.

With a motion by Dr. Lewis, seconded by Mr. Campbell, the motion passed unanimously by a roll call vote of the members present to recommend to the Board to approve the low bidder on the bid tabulation for Bread and Bread products for July 1, 2017 through June 30, 2018.

Mrs. Lemoine next again welcomed Mrs. Blum, to present a request for permission to advertise quote solicitation schedule for Fresh Fruits and Vegetables for the period of July 1, 2017 through June 30, 2018.

With a motion by Mrs. Asevedo and a second by Mr. Gaines, the Committee voted unanimously by a roll call vote of the members present to recommend to the Board to approve the Administration's request to advertise quote solicitation schedule for Fresh Fruits and Vegetables for the period of July 1, 2017 through June 30, 2018.

Under Superintendent's Recommendations Ms. Voitier reminded everyone that before the Regular Monthly Meeting on May 23, 2017 there will be a Public Hearing regarding the 2017 – 2018 General fund and Special Revenue Funds budgets. She noted that there will also be recognition of the annual financial awards that are to be bestowed upon the school system. She also noted that the Academic Game National Team will be honored for their performance at the National Competition. Mrs. Voitier also reminded everyone about the Chalmette High School Graduation on Thursday, May 11, 2017 at the UNO Arena.

Mr. Long requested an open house at the new Meraux Elementary School before school opens in August.

There being no further business to discuss and on motion of Mr. Campbell, seconded by Mrs. Asevedo, and passed unanimously by voice

vote, the meeting was adjourned.

On motion of Mrs. Asevedo, seconded by Mr. Gaines, the Board voted unanimously by a roll call vote of the members present to approve the minutes of the Regular Monthly Meeting of October 25, 2016 as published on December 2, 2016.

On motion of Mr. Campbell, seconded by Dr. Craft, the Board voted unanimously by a roll call vote of the members present to approve the minutes of the Regular Monthly Meeting of January 24, 2017 as published on May 5, 2017.

On motion of Mr. Warner, seconded by Mr. Gaines, the Board voted unanimously by a roll call vote of the members present to approve the minutes of the Regular Monthly Meeting of February 21, 2017 as published on May 5, 2017.

On motion of Dr. Craft, seconded by Mr. Campbell, the Board voted unanimously by a roll call vote of the members present to approve the minutes of the Special Meeting of March 14, 2017 as published on May 19, 2017.

On motion of Mr. Gaines, seconded by Mr. Egan, the Board voted unanimously by a roll call vote of the members present to approve the minutes of the Regular Monthly Meeting of March 28, 2017 as published on May 19, 2017.

With no recommendation from the Committee, the Board considered a motion to approve a resolution providing signature authority for the Superintendent to sign the St. Bernard Parish School Board Grant Agreement package for the Orchard Foundation. That Resolution is shown below:

RESOLUTION

STATE OF LOUISIANA, PARISH OF ST. BERNARD

On the 23rd Day of May 2017, at a meeting of the School Board of St. Bernard Parish held in the city of Chalmette, a quorum of the Members present, the following business was conducted:

It was duly moved and seconded that the following resolution be adopted:
