### VOTER INFORMATION

#### VOTER REGISTRATION

In order to vote on the **Annual School District Budget and Trustee Election** on **Tuesday, May 20, 2025** you must be registered to vote. If you wish to register to vote you may do so with the District Clerk at the Central Administration Offices, 1600 Washington Avenue (Manor Elementary School). You must bring proof of identity and residence when you come to register.

1. Must be 18 years of age or older.
2. An American Citizen.
3. A resident of the Seaford School District for at least 30 days prior to the vote.

Registration of voters not previously registered and eligible to vote shall continue to take place until 4:00 p.m. on May 13, 2025 as follows:

1. Monday – Friday between the hours of 9:00 a.m. and 3:00 p.m. in the District Clerk's Office
2. Before and after the Wednesday, May 7, 2025 Budget Hearing/Board Meeting
3. Saturday, May 10, 2025 between the hours of 9:00 a.m. and 12:00 noon
4. By Appointment

**Please note:** If you are registered to vote for the general election with the Nassau County Board of Elections, then you are eligible to vote. Please call Carmen Ouellette at 592-4003 if you are unsure of your registration status or have any other questions.

#### IN-PERSON VOTING LOCATIONS

Voting will take place on Tuesday, May 20, 2025 during the hours of 7:00 a.m. to 9:00 p.m. at the Manor Elementary School, 1590 Washington Avenue, Seaford, NY and at the Harbor Elementary School, 3500 Bayview Street, Seaford, NY. Polling will be held in the gymnasium in each location.

Residents who reside within the geographic boundaries of the Manor Elementary School are required to vote at the Manor Elementary School.

Residents who reside within the geographic boundaries of the Harbor Elementary School are required to vote at the Harbor Elementary School.

### VOTER INFORMATION (continued)

#### ABSENTEE BALLOTS/EARLY MAIL-IN BALLOTS

Application for absentee and early mail ballots for the school district and public library election may be made at the District Clerk's office on Mondays through Fridays, excluding holidays, between the hours of 9:00 a.m. and 3:00 p.m. Applications for absentee or early mail ballots must be received by the District Clerk no earlier than thirty (30) days before the election. Furthermore, such application must be received by the District Clerk at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be delivered personally to the voter or his/her designated agent. Upon receiving a timely request for a mailed absentee or early mail ballot, the District Clerk will mail the ballot to the address set forth in the application by no later than six (6) days before the vote. No absentee or early mail voter's ballot will be canvassed unless it has been received in the office of the District Clerk not later than 5:00 P.M. (prevailing time) on the day of the election. A list of all people to whom absentee and early mail ballots shall have been issued will be available in the District Clerk's office on Mondays through Fridays, excluding holidays between 9:00 a.m. and 3:30 p.m., until the day of election.

**Please Note:** If you are registered as a permanently disabled voter with the Nassau County Board of Elections, an absentee ballot will automatically be sent to you.

#### MILITARY BALLOTS

Military voters who are not currently registered may apply to register as a qualified voter of the school district. Military voters who are qualified voters of the school district may submit an application for a military ballot. Military voters may designate a preference to receive a military voter registration, military ballot application or military ballot by mail, facsimile transmission or electronic mail in their request for such registration, ballot application or ballot. Military voter registration forms and military ballot application forms must be received in the Office of the District Clerk no later than 5:00 p.m. on April 25, 2024. No military ballot will be canvassed unless it is (1) received in the Office of the District Clerk before the close of the polls on election day and showing a cancellation mark of the United States postal service or a foreign country's postal service, or showing a dated endorsement of receipt by another agency of the United States government; or (2) received by the Office of the District Clerk by no later than 5:00 p.m. on election day and signed and dated by the military voter and one witness thereto, with a date which is associated to be not later than the day before the election.
