CALL TO ORDER / ROLL CALL

Vice Chair Juliet Walker called the School Committee Business meeting of the Newburyport School Committee to order at 6:30 PM. Roll call found all members present except Mayor Reardon (arrived at 7:30). All those present stood for the Pledge of Allegiance.

2025-2026 High School Athletic Fees

Members reviewed the athletic fee list, noting the fee list was actually for 2025-2026. James Antonelli explained the proposed increase for Boys and Girls Ski teams is to get away from fundraising.

Student Representative Report

Maddie Jackman presented the student report that included Kindness Month activities and Global Day of Play at the Bresnahan, Spirit Week at the Molin, Community Basketball fundraiser at the Nock, and congratulations to the Mock Trial Team, as well as various musicians at the high school.

Newburyport's Whittier School Committee Rep

Brett Murphy reported that Whittier was closed today due to a water main break. He stated the Plant Operations Subcommittee will meet on February 4th to conduct interviews to select a project manager for the wastewater treatment plant study. Three bidders applied to the RFP.

Mary DeLai reported that Whittier has launched their budget process. The school committee will meet on February 26th, and the public hearing on the budget will be held on March 12. They are entering negotiations with the teacher's union. Mary also spoke of the admissions policy review and evening adult learner programs.

NHS Cell Phone Follow Up

High School Principal Andy Wulf stated the high school has done a lot of work focused around engaging students on healthy behavior as it relates to smart devices. Principal Wulf explained the three main drivers at NHS: growth, readiness and voice. He provided a brief history of the high school's cell phone policies and strategies.

Principal Wulf described the student dialogues run by grade 11 and 12 English teachers as part of the summer reading program (Gr 11 read *Accountable* and Gr 12 read *Atomic Habits*). High school students Emerson Leahy and Tyler Chorebanian shared their personal strategies to self-regulate their cell phone use, which they recently shared at assemblies for grade 9 and 10 students. The Senior English classes will be involved in an upcoming student dialog topic, "*Why your attention matters*". Future activities may include a possible intergenerational dialogue involving parents, teachers and students, as well as working with the IT group to limit apps on iPads.

Proposed Business Manager Hiring Process

Juliet Walker explained the details of the proposed advisory committee that would assist with the hiring process for a school business manager. Members interested in serving on the committee should contact Mayor Reardon.

Finance Subcommittee

Brian Callahan reported they will meet on Thursday, February 13th at 8:00AM.

Policy Subcommittee:

Juliet Walker stated the next meeting will be held on February 10th.

Communications Subcommittee

Sarah Hall reported they met on January 23rd. They set the meeting calendar for the remainder of the year (last Thursday of each month from 5-6pm, except May 1st due to school break). They also reviewed successors for 2024 and various action items for 2025. The next meeting will be held on February 27th.

Teaching & Learning Subcommittee

Breanna Higgins stated they held the first meeting on January 27th. They went through an overview of mid-year assessments used by the district and also had a long conversation about the competency determination. Future meetings will be held on the fourth Monday of each month.

Evaluation Subcommittee: have not met

Review 2025-2026 School Calendar – DRAFT

Members reviewed the proposed 2025-2026 calendar. This was the first reading of the 2025-2026 calendar; a second reading and possible vote will occur at the February 25th meeting.

Brian Callahan explained his version of the calendar. He moved many Early Release Days to a Friday prior to a vacation or holiday, which is beneficial to families.

In response to Brian Callahan's proposal, Superintendent Gallagher stated he is concerned about increased district-wide absences when an Early Release Day falls before a holiday/vacation. In addition, the April 3rd ERD cannot be moved due to the AFSCME contract. The Superintendent could move the March 27 ERD so if doesn't fall right before the April 3rd ERD.

Sarah Hall commented that early release days are longer work days for teachers, therefore if ERDs were moved, teachers would have to work until 4PM the day before holidays and/or vacation weeks rather than work their normal day.

Breanna Higgins asked if it would be beneficial to have fewer early release days, and condense them into full days. Also, what is rationale for later start / earlier finish for Pk-K in calendar year. The Superintendent will obtain more information from the Administration.

Superintendent's Report

AD Hiring Process Update: Four candidates met with the high school team, made up of Principal Wulf, Lauren Gee, Mike Testa, Nick Markos, James Antonelli, and Marshall Simons. Principal Wulf will make his final hiring recommendation to the Superintendent this week.

FY26 Budget Update: Superintendent Sean Gallagher shared that the Governor’s proposed FY26 budget provides over \$6 million for Chapter 70 funding to Newburyport, which is a \$152K increase.

MASS Refugee Support Webinar: Superintendent Gallagher participated in a refugee support webinar sponsored by MASS, which provided helpful guidance and feedback to all school districts. The district has protocols and policies in place. The EL staff have been provided with information that can be supplied to any families they are working with if needed.

MASS Winter Conference: Superintendent Gallagher attended the winter conference with area superintendents. This year’s topics included a presentation and review of a Social Media Toolkit, strategies districts are using to deal with social media, student’s mental health and depression related to social media, and opportunities for Artificial Intelligence in schools.

- Kathleen Shaw thanked everyone for participating in the Community Talent show.
- Kathleen Shaw said SEPAC recently held a planning meeting. The next meeting will be in person on Thursday, February 27th. They are working to establish dates for future meetings and topics.
- Mayor Reardon reminded everyone that the State of the City Address and the Community Awards will be at 7PM on Wednesday, February 26th at City Hall.

The Superintendent will ensure the district has and follows a written set of procedures in grant administration that aligns with state and federal laws and regulations.

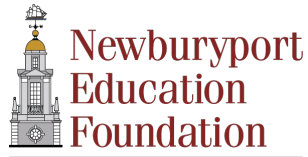

**In Loving Memory of Jane G. Politis
Newburyport High School, Room #210
Naming Rights Amount: \$5,000**

Jane Politis dedicated 25 years of her life to Newburyport High School. She taught psychology, sociology, history, civics, and the "Leadership Seminar", a class focused on gifted and talented students. Jane attended Stanford University and majored in Political Science, and also studied and spoke Italian and Russian. Her undergraduate years were highlighted by a study abroad in Italy and extensive travel throughout Europe and Morocco.

Jane was nominated by her students for making a difference in their lives and was honored by being named "Who's Who Among America's Teachers." In 1998, she was nominated as a finalist for Teacher of the Year in Massachusetts. She was also presented with the Edward G. Molin Award for teaching excellence within the Newburyport School System. Jane cherished her time in Newburyport as a teacher and loved spending time with her students.

The Politis Family named a room after Jane's late husband, Stephen Politis, in 2022. They were so moved by the room naming and support of it from the Newburyport community that they decided to honor Jane in the same fashion. Her room will be directly across the hall from Stephen's room.

**Cindy M. Johnson Video Production Studio
Newburyport High School, Room #112
Naming Rights Amount: \$50,000**

It is important to note that over 40 individuals, companies and organizations donated over \$50,000 (and this number is still climbing) to honor Cindy in this way because of her commitment to not only Newburyport's Public Schools but the Newburyport Community.

Cindy earned her undergraduate degree in German Language and Literature from Wartburg College and went on to complete her Master's degree in the same field at the University of California, Davis. After holding executive roles at Addison Wesley, Cindy founded her own publishing company, which she successfully led for 38 years, specializing in non-traditional workflows and products, managing projects for prominent

Naming New Facilities

Naming a school facility is an important matter that deserves thoughtful attention. Personal prejudice or favoritism, political pressure, or temporary popularity should not be an influence in choosing a name for a school, a portion of a school, or a portion of school grounds. Whenever possible, the wishes of the community, including parents/guardians and students, should be considered in naming school facilities.

The School Committee has the authority to approve the naming and renaming of buildings, structures, and facilities located on School District property. The School Committee also has the authority to name subsections of existing structures or facilities, such as classrooms, auditoriums, and gymnasiums.

Names and/or wording associated with school facilities shall be consistent with school district policies and promote messages aligned with the mission, vision and goals of the school district. To the extent possible, names and/or wording should be designed not to restrict the use of a space or inhibit changing the function of the space should that become necessary in the future.

When the opportunity to name or dedicate a new school or school related property, structure or facility is forthcoming, an orderly procedure will be communicated at the next available School Committee meeting. The Committee's agendas should clearly reflect the intent to consider, review, and vote on naming opportunities.

The School Committee may elect to authorize the designation of naming rights for specific portions of District facilities through advanced approval of a list of naming opportunities to be reviewed annually; provided such designation benefits the District and the Committee retains final approval over any name associated with School District structures or facilities.

An offer of a financial contribution to the School District may accompany a naming request, but the School Committee is not obligated to accept or reject a name based upon financial considerations alone.

IC/ICA: SCHOOL YEAR / CALENDAR

The school calendar for the ensuing year will be prepared by the Superintendent and submitted to the School Committee for approval annually. The number of days or instructional hours scheduled for the school year will be determined in accordance with the following standards set by the Massachusetts Board of Elementary and Secondary Education:

1. Elementary school will operate for a minimum of 180 days. Schools shall ensure that every elementary school student is scheduled to receive a minimum of 900 hours per school year of structured learning time, as defined in regulation. Time which a student spends at school breakfast and lunch, passing between classes, in homeroom, at recess, in non-directed study periods, receiving school services, and participating in optional school programs shall not count toward meeting the minimum structured learning time requirement for that student.
2. Secondary schools will operate for a minimum of 180 days. Schools shall ensure that every secondary school student is scheduled to receive a minimum of 990 hours per school year of structured learning time, as defined in regulation. Time which a student spends at school breakfast and lunch, passing between classes, in homeroom, at recess, in non-directed study periods, and participating in optional school programs shall not count toward meeting the minimum structured learning time requirement for that student.

For the information of staff, students, and parents, the calendar will set forth the days schools will be in session; holidays and vacation periods; in service days; and parent conferences.

Newburyport School Calendars will always follow these guidelines with regards to setting a starting date for school:

- The Friday before Labor Day will always be a no-student day and a non-work day for educators.
- Before the full beginning of the year, time will be set up to allow students in transition years (1, 4, 6, and 9) time in their new buildings to become acclimated before all students arrive.
- New-teacher orientation and otherwise stipended days are not considered “regular faculty days” and can therefore take place outside of this policy.
- In years when Labor Day falls between September 1- 4, school will start after Labor Day,
 - o Regular faculty days will also start after Labor Day unless specifically requested for approval by the Superintendent and applicable labor unions.
 - o All students grades 1-12 will have at least 1 complete school day during this first week of programming.

- In years when Labor Day falls between September 5-7, we will start school during the week before Labor Day.
- Regular faculty days will not start before the Monday before Labor Day.
- All students grades 1-12 will have at least one complete school day during this first week of programming.
