15- 287 **DISCUSSION OF POLICIES**

The homework policy was discussed by the board. Elementary teachers attended to discuss their procedures. In grades Pre-K, K & 1 – skill worksheets are sent home in response to parents asking what they can do at home with their child to help them progress. It allows the parents to see what the children are working on and struggles, if any, with the work. It opens up the line of communication with parents. In most cases, the worksheets are ungraded, and given over a few days to complete. Worksheets are usually a review of the day/week's taught lesson and are given as reinforcement. Second grade does require 15 minutes of reading nightly and students have made great improvements over the school year by participating. All the teachers agreed that it is a They have modified programming to good way to communicate with parents. accommodate a particular student's ability. It helps with the transition to the upper grades especially with following directions and being responsible for their work assignments. By the time they reach the fourth grade level, they are familiar with a daily routine. Mrs. Kelly asked if the Pre-K worksheets were new. Mrs. Trievel responded that it was started a couple of years ago because some students in her class were asking why they didn't have homework like their older siblings and as a response to parents asking for something to work on at home with their child. Mrs. Trievel also reported that she doesn't start sending anything home until mid-year when she thinks they are ready.

Mrs. Nowicki commented that the homework today is focused on learning and not busy work. The math program is more intensive than in earlier years. There is a focus on vocabulary and reading from early on.

Dr. Stalker commented that reading should not have to be assigned. Parents should recognize that the more you read, the more beneficial it is. Vocabulary and comprehension skills are a direct result of reading on a regular basis. It's our hope that all students read nightly and will learn to enjoy reading for pleasure. You cannot do well in math coursework today without the comprehension/vocabulary skills.

The board will continue the discussion at the next meeting along with a discussion on building use.
