Karen Evans made the motion, seconded by Richard Allen to adopt the following resolution of appointment:

**RESOLVED**, that the Board of Education, Holland Patent Central School District, pursuant to Section 2509 of the Education Law and in compliance with Part 30.3 of the rules of the Board of Regents, upon the recommendation of Dr. Kathleen M. Davis, Superintendent of Schools, does hereby appoint **Kirk Smith**, 400 Plymouth Drive, Syracuse, New York, who holds a New York State Initial Certificate #xxxxxx in Chemistry Grades 7-12, to the position of chemistry teacher, for a probationary period of four (4) years in the tenure area of Chemistry Grades 7-12 Education, to commence September 1, 2016 and to expire on August 31, 2020, (unless extended in accordance with the law). This expiration date is tentative and conditional only. Except to the extent required by the applicable provisions of Section 3012<sup>3</sup> of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective in at least three (3) of the four (4) preceding years, and if the teacher receives an ineffective composite or overall rating in the final year of the probationary period the teacher shall not be eligible for tenure at that time. **AND BE IT FURTHER RESOLVED** that Kirk Smith be paid on Step B-19 (\$54,255) effective September 1, 2016.
