**APPOINTMENT OF ASSISTANT PRINCIPAL/DIRECTOR OF ATHLETICS**

Everett Stalker made the motion, seconded by Lydia Kelly to adopt the following resolution of appointment effective September 1, 2016:

RESOLVED, that upon the recommendation of Kathleen M. Davis, Superintendent of Schools, the Board of Education of the Holland Patent Central School District, does hereby appoint **Tamara-Anne Barbour**, 311 East Market Street, Long Beach, NY 11561, who holds an Initial New York State Certificate permitting her to serve as a School Building Leader, in the tenure area of School Building Leader, to the twelve (12) month position of Assistant Principal/Director of Athletics for a probationary period of four (4) years to commence on September 1, 2016 and to expire on August 31, 2020 (unless extended in accordance with the law). This expiration date is tentative and conditional only. In order to be granted tenure the administrator must receive composite or overall annual professional performance review ratings pursuant to Section 3012-c and/or 3012-d of the Education Law of either effective or highly effective to the extent required by the applicable provisions of the Education Law, the Rules of the Board of Regents and the Regulations of the Commissioner of Education, and if the Administrator receives an ineffective composite or overall rating in the final year of the probationary period the administrator shall not be eligible for tenure at that time. **BE IT FURTHER RESOLVED** that Tamara-Anne Barbour be paid a salary of \$85,000.
