Dear Holland Patent School District Community,

The Board of Education adopted the spending plan of \$40,436,507 for the 2024-2025 school year at the February 29, 2024 meeting. The budget supports a solid curriculum which seeks to prepare students for college and career readiness. We have utilized flexible thinking and planning to produce a budget that maintains programming in the face of multiple challenges. The state aid reductions currently being considered and the rate of inflation in New York State has presented many challenges, and through long term financial planning our district has worked diligently to present a budget that stays within our tax levy limit at 2.90%. This would not have been possible without the efforts of our teachers, staff and students, as well as the support from our community. The spending plan that has been constructed is fiscally responsible to our taxpayers in the long and short term, while continuing to maintain the solid educational programs that are essential to our students' success today and in the future. We have maintained a hearty offering of extracurricular and athletic offerings to our students. It has been a positive and productive time in our school buildings across the district.

Some highlights, amongst other wonderful opportunities, in our budget are inclusive of the following examples of our programs:

- Languages: Spanish, French, Mandarin Chinese, American Sign Language
- Arts: Photography, Computer Graphics, Drawing and Painting, Digital Design, Sculpture
- Technology: CAD, DDP, Computer Applications
- Physical Education: Life Saving, Health, PE Pre-K-12
- Music: Guitar 1 & 2, Chorus, Select Chorus, Jazz Band, Vocal Ensemble, String Ensemble, Music Theory, K-8 General Music, Chamber Orchestra
- MVCC: English 101, Government, Economics, CAD, Accounting, Computer Applications, Music Appreciation, French, Spanish, Psychology, Sociology, Pre-Calculus, Calculus, Statistics
- Herkimer College: ASL 3, ASL 4
- AP Courses: Calculus, Biology, Language and Composition, US Government, US History and Government, Modern World History, Music Theory
- Sports: Football, Tennis, Swim, Soccer, Field Hockey, Cross Country, Cheerleading, Basketball, Wrestling, Bowling, Volleyball, Alpine and Nordic Ski, Baseball, Softball, Golf, Track and Lacrosse

As a team, we have worked on supporting a strategic plan as a Board of Education, leadership team, faculty, staff and community which aligns our focus on the Mission, Vision and District Goals for the future. As we digested the ideas from this plan, focusing on a commitment to student growth, we are focused on a balanced approach to facilities improvement. The Capital Project that was approved by voters last May will begin implementation this summer and throughout the coming school year.

We are future focused, with students centered at our core. Some of our current points of pride include:

- Investment in Early Literacy – Full-day pre-K
- Building Literacy Capacity K-12
- Teacher Center professional learning that supports District initiatives and building capacity
- Differentiated professional learning with technology integration
- Instructional coaching K-12 focused in reading, writing and math
- Connected Community Schools, which are located in every building
- Hubs located in every school with food pantry, clothing closet and school supplies
- LINKS referrals to outside agencies including mental health, housing, family needs, academics, nutrition, medical needs, transportation and behavior management
- Dual Credit Courses – Syracuse University Project Advance, MVCC, Herkimer College, Utica University, Hamilton College
- Career and Technical Education, P-TECH, New Visions, Regional Program for Excellence
- Summer programming for K-6 enrichment at Holland Patent
- Summer camps, including athletics, STEM, art and music
- Accrual of 54 dual-credits available to all students attending our high school
- Best community for music education for five consecutive years
- Mentoring program for new staff
- Updating curriculum to ensure the Next Generation standards are embedded
- Instructional coaches are building small group instruction in the classrooms
- Using student data to drive instruction and fill gaps due to learning loss
- Multiple Extracurricular opportunities including FFA and FBLA

These points of pride are supported through a fiscally responsible proposed budget. The proposed 2024-25 tax levy is a 2.90% increase from the 2023-24 budget. The tax levy limit requires districts in New York State to apply a multistep formula to determine the tax levy increase a district can propose. We will once again stay within this tax levy limit. The Board of Education adopted a spending plan of \$40,436,507 for 2024-2025 school year, which results in a levy below the district maximum allowable levy limit.

Many years of financial planning has helped us to build a budget that engages student centered learning and is fiscally responsible with a tax levy under the allowable levy limit. We would like to thank everyone who put forth a great deal of effort in the development of the budget. We invite all residents to attend the public hearing at Holland Patent High School on Tuesday, May 7, 2024 at 6 p.m. The budget vote will be Tuesday, May 21, 2024 from 10 a.m. - 8 p.m.

PUBLIC LIBRARY BUDGET PROPOSITION

New York state education law allows libraries to place a funding proposition on school district ballots and requires school districts, at the libraries' requests, to levy and collect taxes for libraries. Libraries are separate legal entities from the school district, with their own funding and budgets. The school district does not endorse, control or recommend any aspect of how the libraries spend money.

If voters approved proposition three, the school district would annually levy and collect taxes in the new amount for the library beginning in the 2024-25 fiscal year. The amount authorized for library services is listed as a separate line on residents' tax bills.

TAX CAP TAX LEVY

WHAT'S THE DIFFERENCE?

In 2011, New York State implemented a tax cap, which limits the amount of property tax revenue that a school district can raise each year. The tax cap is calculated based on a formula that takes into account the district's property values, the rate of inflation and certain exemptions. The purpose of the tax cap is to help control property taxes and prevent them from increasing too rapidly.

On the other hand, the tax levy is the total amount of money a school district raises through property taxes to fund its budget. The tax levy is determined by the district's financial needs such as salaries, benefits, programs and facilities. The tax levy can also be impacted by other factors such as state aid, enrollment changes and the need for capital improvements.

So, how does the tax cap and tax levy affect you as a taxpayer? If a district proposes a tax levy increase that is below the tax cap, then the budget can be passed with a simple majority vote. However, if the proposed tax levy increase is above the tax cap, then the budget requires a supermajority vote of 60% or more to pass.

It is important to note that the tax cap does not limit your individual property tax bill; rather, it limits the total amount of property tax revenue that the school district can raise. Your individual tax bill can still increase more than 2% even if the tax levy increase is below the tax cap, because the school budget is not the only factor impacting your tax bill. Individual tax bills are also determined by the assessed value of your property, which can change from year to year. The Holland Patent Central School District encompasses multiple towns, all with different formulas for assessing properties.

We hope this information helps clarify some common questions regarding property tax bills and school budgets.

TAX CAP

Limits the amount of property tax revenue that a school district can raise each year.

TAX LEVY

The total amount of money a school district raises through property taxes to fund its budget.

SIMPLE MAJORITY

50% of all people who vote must vote yes for a budget to pass.

SUPER MAJORITY

60% of all registered voters must vote yes for a budget to pass.

As a special celebration (with some math included), we were also celebrating the 1,000th day of school for our fifth graders (class of 2031).




MIDDLE SCHOOL STUDENTS ATTEND **ECLIPSE** *Workshop*

Middle school students attended an eclipse workshop led by Mrs. Kiehn and Mr. Eberley. Students created eclipse T-shirts using the reverse tie-dye method. By carefully spraying a bleach and water solution, students watched as the color lifted from their black T-shirts. Paper plates were used to mask the shirts, resulting in a ring of orange that represents the corona of the sun.

While students waited for their shirts to dry, they watched a video on what causes the solar eclipse, looked at simulations of totality from NASA, and explored three activities: making the corona of the solar eclipse with chalk on black paper (similar to their T-shirts), creating the totality shadow of the moon on the Earth during a solar eclipse, and determining what the solar eclipse would look like from Earth as the moon blocks out the sun.

Students left the workshop with some fun information, important things to look for during the solar eclipse, and of course, their T-shirt!





Voter Information

What am I voting on?

A budget of \$40,436,507 for the 2024-25 school year, a proposition to purchase school buses, a proposition to authorize a non-voting student board member, a proposition to increase the appropriation of each of the three libraries from \$10,000 per year to \$20,000 per year, and one candidate for the Board of Education.

When and where is the vote?

Tuesday, May 21, 2024 from 10:00 a.m. to 8:00 p.m. in the Holland Patent High School gymnasium.

Who is eligible to vote?

Anyone who is a U.S. Citizen, 18 years or older, and a resident within the district for a period of 30 days prior to the vote. A resident is not eligible to vote if they are prohibited from voting under the provisions of Section 5-06 of the Education Law.

How can I vote by absentee or early mail ballot?

Applications for absentee or early mail ballots for the 2024 annual meeting will be available beginning April 23, 2024, and may be picked up from the Office of the District Clerk at Holland Patent Central School District, 9601 Main Street, Holland Patent, NY 13354, or requested to be mailed by calling 315-865-7221. For voters requesting a ballot delivered to them by mail, completed applications must be received by the District Clerk no later than May 14, 2024. For voters requesting a ballot delivered to them personally, completed applications must be received by the District Clerk no later than May 20, 2024. All completed absentee ballots must be received by the District Clerk's Office no later than 5 p.m. on May 21, 2024. All completed early ballots must be received by the District Clerk's office no later than May 20, 2024.

What about military voters?

Military voters who are qualified voters of the District may apply for a military ballot by requesting an application from the District Clerk at 315-865-7221 or vmarris@hpschools.org. For a military voter to be issued a military ballot, the District Clerk must have received a valid ballot application no later than 5 p.m. on April 25, 2024. In a request for a military ballot application or ballot, the military voter may indicate their preference for receiving the application or ballot by mail, facsimile transmission or electronic mail.
