**VII. Primary Facilities Update**

Mr. Weber provided an update from the most recent CORE Team meeting that was held on April 2<sup>nd</sup>. Discussion included a review of feedback from the Hilltop design workshop in design elements, preliminary planning for Elm temporary instructional space, and a timeline for Hilltop logistics. A review of upcoming calendar events was reviewed, including the next design workshop at Hilltop on May 13<sup>th</sup> and the Hilltop building retirement party on May 22<sup>nd</sup>.

**VIII. Policy Update**

Mr. Weber provided an update to the Policy discussion held at the March 31<sup>st</sup> Board meeting. Several policies are being further reviewed by legal counsel. Following the recommendations from legal counsel, the BOE can review any potential changes at the planning meeting on May 6<sup>th</sup> with a first read scheduled for May 19<sup>th</sup>.

**IX. State Biennium Budget Update**

Mrs. Johnson shared that the State biennium budget process continued with amendments from the Ohio House of Representatives. The House budget proposal pauses the Fair School Funding Plan and proposes a bridge formula, which drives more state funding to Wyoming than the Governor's budget proposal. However, the House budget proposal also includes a provision that reduces voter-approved property tax rates when cash balances are deemed too high, which is a major shift in tax policy. Mrs. Johnson noted that the District submitted written advocacy to the House and Senate in opposition to this provision and the District will continue to monitor the budget activity.
