#### SUPERINTENDENT'S MESSAGE

#### Dear Oriskany Central School District Community,

I hope that this message finds you well and that you are enjoying the warmer and longer days of spring. I would like to extend my gratitude to the entire school community for your continued support and dedication to the Oriskany Central School District.

This is an exciting time of year as we begin to prepare for the end of the school year. The months of May and June are filled with events, activities and ceremonies that celebrate the incredible accomplishments of the 2024-2025 school year. Please be sure to check our website and social media for the latest updates about end-of-year activities and events.

#### **Budget Overview:**

It is also the time of year when we present the 2025-2026 school budget for your consideration. Our commitment to excellence in education remains unwavering, and our efforts to maximize our resources to efficiently and innovatively meet the goals and objectives of our academic programs are central to our mission. Throughout the last several months we have been working diligently to put together a spending plan that maintains and enhances our academic programs while remaining fiscally responsible to our community.

This year's budget proposal has proven to be very challenging. After a flat increase in our state aid for the 2024-2025 school year and the governor's proposed 2% increase for this year, we are seeing compounding gaps in our revenue from the state. (As of this writing, we still don't have a finalized state budget.) As you know, state aid contributions make up roughly 50% of our revenues, while the other roughly 50% comes from our Tax Levy, Payments in Lieu of Taxes (PILOTS), Appropriated Fund Balance and Local Non-Tax sources. Some other challenging factors that we are facing for the 2025-26 budget include a double-digit percentage increase in our health insurance contributions (outside of our control); continued increases to our program costs, especially special education programs/services; and collective bargaining agreement contractual increases for our employees.

This year we are proposing a \$19,467,028 budget with a 4.83% or \$342,271 increase to our tax levy. This tax increase is in line with what was approved for the 2024-2025 school year, and remains tax cap compliant under this proposed budget. With lower state aid coming into the District combined with continuing increased costs to do business, we are looking to maintain our programs and services while remaining fiscally responsible. This budget will provide the necessary resources to continue to build upon our proud mission, "To educate, engage, and empower students to excel in an ever-changing world. We are committed to our tradition of personal attention, positive relationships, and an innovative climate for learning."

Our budget for the upcoming fiscal year reflects a comprehensive approach to meeting the diverse needs of our students while maintaining fiscal responsibility. Through careful planning and strategic allocation of resources, we aim to enhance educational opportunities and support the holistic development of every learner.

#### **Key Budget Priorities:**

- Academic Enrichment: Investing in curriculum development, instructional resources and professional development programs to promote academic excellence and student success.
- 2. Technology Integration: We recently made the switch to the Managed IT Services (MITS) through Madison-Oneida BOCES. This service is a comprehensive service that provides leadership, technology planning and a team of IT experts for the District to support our technology needs.
- 3. Support Services: Strengthening student support services, including counseling, special education and wellness initiatives to ensure the well-being of every student.
- Facilities Maintenance: Continued investment in facility maintenance and upgrades to create safe, conducive learning environments for students and staff.
- Community Engagement: Building partnerships with families, community organizations and stakeholders to promote collaboration and enrich the educational experience.

#### Looking Ahead:

We remain committed to transparency and accountability in our financial practices. Our budgeting process involves input from various stakeholders, including parents, staff and community members. We encourage active participation and feedback to ensure that our budget reflects the priorities and values of our community in the upcoming budget discussions and vote.

#### **Dear Oriskany Central School Community:**

At our April 15, 2025 meeting, the Oriskany Board of Education approved a \$19,467,028 budget for the 2025-2026 school year. This budget represents an increase in appropriations from the 2024-2025 budget and is reflective of our commitment to maintaining a high-quality educational program within the financial means of our state and our community. We continue to maximize monies and services by working in partnerships with BOCES, federal, state and local governments, and continue to look for cost efficiencies throughout the operational aspects of our school district.

The proposed 2025-2026 budget also includes a tax levy that stays within our maximum allowable tax cap of 4.83% and therefore will require a simple majority vote.

This year's budget proposal again demonstrates our enduring support of a comprehensive educational program that continues to provide creative and innovative learning opportunities for our students to enhance their educational experiences, and a rigorous and relevant curriculum that prepares students to be college and career-ready.

The Oriskany Board of Education believes the 2025-2026 proposed budget offers the best possible balance of a continued commitment to a comprehensive education for our children of Oriskany while maintaining an affordable value for our residents and members of our community. We appreciate your consideration of this proposal and urge your participation in the voting process on Tuesday, May 20, 2025, held from noon to 8:00 p.m. at the Jr./Sr. high school atrium (rear).

#### 2025-26 PROPOSED BUDGET WHAT YOU NEED TO KNOW

The District budget vote, along with the Board of Education election, will be held on **Tuesday, May 20, 2025, from 12:00 noon to 8:00 p.m., in the atrium (rear) of the Jr./Sr. high**. If the proposed budget is passed by voters, it will be enacted for the 2025-2026 school year. If not passed, the Board of Education can:

- Place a revised budget before District residents for a vote.
- Place the same budget before District residents for a vote.
- Immediately adopt a contingency budget.

Should the proposed budget be defeated and a contingency budget is adopted pursuant to Section 2023 of the Education Law, \$631,550 will be eliminated in equipment purchases, student supplies, the multi-year copier contract, and additional items to be determined by the Board of Education for the 2025-2026 school year.

#### **EARLY MAIL VOTING & ABSENTEE BALLOTS**

Applications for early mail voting and absentee ballots are located on the school District website or at the District Office from 8:00 a.m. to 4:00 p.m., Monday-Friday, beginning April 22, 2025. Completed applications must be filed with the District Clerk at least 7 days before the election if the ballot is to be mailed to the voter. Otherwise, the application may be personally delivered to the District Clerk no later than the day before the election. If you are qualified for absentee voting and issued an absentee ballot, the ballot itself must be received by the School District Clerk by 5:00 p.m. on the day of the election in order to be canvassed.

#### TO VOTE YOU MUST BE

- A U.S. citizen;
- At least 18 years of age;
- A resident of the District for at least 30 days prior to the date of the election, and who is not otherwise ineligible to vote under the provisions of Section 5-106 of the Election Law.




While the tax levy limit is often referred to as a "2% tax cap", each district is required to annually calculate their specific tax levy limit in accordance with a formula that accounts for individual district conditions and variables. For districts across New York State, this calculation rarely results in a limit of exactly 2%, calculated rates can vary as high as 6% or more. For Oriskany CSD, this proposed tax levy increase of 4.83% does not exceed the tax levy limit and requires a simple majority vote.

#### THREE COMPONENT BUDGET

The state legislation which requires the state's school districts to have a public budget vote includes the requirement that the budget be divided up into three components: Program, Capital and Administration.

**ADMINISTRATION COMPONENT:** Provides funding for the support services of the District. This component is comprised of those expenses which are associated with the BOE, Central Administration and Central Services.

**CAPITAL COMPONENT:** Comprised of those expenses which are associated with the operation and maintenance portions of the budget. Also included in this component is debt service.

**PROGRAM BUDGET:** Generally the largest portion of the District budget. This portion covers general instruction, special education, BOCES instructional programs, curriculum and staff development. Additionally, pupil support services such as counseling, library, health, co-curricular, interscholastic and transportation are included in this component.

If the proposed budget is defeated twice, the Board of Education must adopt a contingent budget. The following items are excluded from a contingent budget: equipment purchases, student supplies, non-essential maintenance, transportation of students under mileage limits set by state law, and public use of school buildings and grounds except where there is no cost to the District. In light of the Property Tax Cap law, under contingency, the school district can levy no more taxes than the amount of taxes levied in the prior school year by the district.

#### Proposition #1

#### **BUDGET RESOLUTION**

RESOLVED, that the Board of Education of the Oriskany Central School District in the County of Oneida, State of New York, is hereby authorized to expend \$19,467,028 for the 2025-2026 school year and to levy the necessary tax therefore?

#### **Proposition #2**

#### ORISKANY PUBLIC LIBRARY

Shall the Board of Education of the Oriskany Central School District levy and collect a tax, pursuant to Section 259 of the Education Law of the State of New York, in the sum of \$40,000 for the continuing support and maintenance of the free library services offered to the District residents by the Oriskany Public Library?

#### **Proposition #3**

#### CAPITAL RESERVE VEHICLE PURCHASES

Shall the following resolution be adopted: RESOLVED that the Board of Education of the Oriskany Central School District in the County of Oneida, State of New York, is hereby authorized to spend \$100,000 from the District's existing Reserve Fund approved by the voters in May 2022 for the acquisition of one (1) 7-passenger hybrid student transport van and one (1) Ventrac Tractor for snow removal and lawn care?

## CANDIDATES FOR THE BOARD OF EDUCATION

Election of three (3) members to the Board of Education, for a three (3)-year term commencing on July 1, 2025, and concluding on June 30, 2028. The vacancy arises from the expiration of the terms of Michelle Anderson, James Chase and Louis Ciotti.

Taxpayers will receive their rebate check because we are within our 2% tax cap calculation.

#### RESOURCE MANAGEMENT STRATEGIES

The 2025-2026 school expenditure plan supports the goals and objectives of maintaining small class sizes, providing exceptional programs, and opportunities for our students. The Board of Education and administration have taken actions to provide an atmosphere of success and prepare our students for career and college readiness. The District is committed to providing safety, personal attention, positive relationships and a productive climate for learning. These areas of focus are reflected in the expenditure budget proposal, including:

- · Completed renovation and update of our facilities as the 22-24 Capital Project came to a close.
- · Increased enrichment activities for students both at the elementary and Jr./Sr. high school buildings.
- · Maximizing grant, state and federal funds to support and offset local funds necessary for school programs.
- · Supporting staff development and improvement through research-proven means that lead to increased student performance.
- · Allocating a large portion of the District's expenditure dollars to focus on supporting educational programs for all students, including new Social Emotional Programs and counseling to support student mental health.
- · Implementation and continued development of a new math curriculaum and support from a teacher on assignment; implementation of a new ELA curriculum to bring the District in compliance with the mandate for the Science of Reading.
- · Involving the community, faculty, staff and students in the quest for a new mascot through committee involvement and voting. The introduction of the new mascot logo, "Skyhawks: Anchored in History Ready for Battle," was unveiled in February 2025.
