

## 2025 JUNIOR POLICE ACADEMY



The Junior Police Academy is offered annually to all Mundelein area middle school students (Carl Sandburg Middle School, Fremont Middle School, and West Oak Middle School). This year's academy will be held daily **June 9<sup>th</sup> – 13<sup>th</sup> from 8:30am-11:30am, at the Mundelein Police Department**. Officer Jessica Sexton, who is also the Police Liaison Officer for District 75, including Carl Sandburg Middle School, will run the program.

The Academy is designed to give students an opportunity to experience how subjects such as mathematics, science, English, and physical education are used and relate to the day-to-day responsibilities of a police officer and why an in school educational experience is so important.

Students should wear gym shoes and workout clothing as there will be some physical fitness portions as well as interactive learning exercises like self-defense tactics, crime scenes, report writing, and public speaking. Guest speakers potentially include a K-9 Officer, a member of the Northern Illinois Police Alarm System (NIPAS) Mobile Field Force Team, and personnel from other specialty positions.
