Dear Wyoming Central School Community,

As I reflect on the past year, I remain incredibly proud of our school community and the collaborative spirit that drives us forward each day. Wyoming Central School continues to be a place of growth, opportunity, and resilience, qualities that shine through in both our students and our staff. Thank you for your continued support, engagement, and belief in the power of public education.

This year, we faced financial challenges that demanded thoughtful planning and community-centered solutions. Even though the state budget hasn't been finalized yet, we have had to move forward and finalize ours, despite the uncertainty around how much state aid we'll ultimately receive. That uncertainty adds another layer to what's already a tough process. Like many districts across New York and the country, we are feeling the effects of inflation, everything from utility bills to contract costs that continue to rise. Still, our commitment hasn't changed, we are here to give our students the high quality education they deserve and prepare them for a successful future.

Budget Priorities and Program Continuation

We're proud to share that, thanks to thoughtful financial planning, we're able to continue two key programs in the 2025–2026 school year: our School Resource Officer (SRO) and our full-day Pre-K program. These programs are important parts of what makes our school feel safe, supportive, and welcoming—from helping our youngest learners get a strong start to making sure our whole school community feels secure.

Capital Outlay Project

The proposed 2025–2026 \$100K Capital Outlay Project is dedicated to enhancing the audio and electrical infrastructure in our main building—specifically, a much-needed upgrade to the sound system in the gymnasium. This project aims to improve sound quality for school concerts, drama presentations, assemblies, and other community events held in this central space.

Having clear, high-quality audio makes a big difference—not just for performances, but for all the important moments that bring our school community together. Whether it's a concert, assembly, or celebration, everyone deserves to hear and feel fully part of the experience. This investment is about more than sound; it's about supporting the arts, strengthening connections, and making those special moments even more meaningful for our students, staff, and families.

Our proposed budget of \$6,365,525 includes a 2% tax levy increase—a small but meaningful step to help us meet today's needs while planning responsibly for the future. As we look to the future, our focus remains on sustainability, equity, and excellence. We will continue to explore creative strategies to support our district, strengthen community partnerships, and invest in professional learning to ensure our educators are equipped to meet evolving student needs.

Voting Procedures

How do I sign in? On the day of the vote between the hours of 1:00 pm and 8:00 pm, go to the sign-in table where you will be required to sign your name and township in which you reside. You will also be asked for the correct spelling of your name, and your address by our election workers. Our Election Workers also reserve the right to ask for a photo ID.

Where and how do I complete the ballot?

At the sign-in table, you will be given a paper ballot and privacy sleeve and then instructed to go to a privacy booth. Once at the privacy booth, review the paper ballot, and make your selection using the pen provided. Be sure to place a or in the square. Select either yes or no for each proposition and select one (1) candidate you would like to see on the Board of Education. After you have finished filling out the ballot, place your folded ballot in the ballot box.

CAPITAL OUTLAY EXCEPTION PROJECT

NYS Law provides that a district may receive building aid in the following aid year for one project each year in the district not exceeding \$100,000. Voter authorization for these projects is obtained by inclusion of funding in the budget presented to and approved by the voters, such must be paid by budget appropriation. Districts may not use borrowed money for these projects. Project components planned for this year's proposed budget include audio and electrical improvements at the main building.

Annual Budget Referendum 2025-2026

What's on the ballot?

PROPOSITION #1: Annual Budget
Shall the following resolution be adopted?
YES NO RESOLVED, that the Board of Education of the Wyoming Central School District shall be authorized to expend the amount of \$6,365,525.00 to meet the expenditures for the fiscal year 2025-2026, AND FURTHER that said Board of Education shall be authorized to levy and collect a tax upon taxable property of the School District in an amount necessary therefore.
PROPOSITION #2: Board Election RESOLVED, to elect one (1) member of the Board of Education for one (1) five (5) year term commencing July 1, 2025 and expiring on June 30, 2030 to succeed Benjamin Chamberlain, whose term expires on June 30, 2025. All board positions are at-large.

PROPOSITION #3: Authorization to withdraw from the existing "2020 Vehicle, Machinery, & Equipment Purchase Capital Reserve Fund"
Shall the following resolution be adopted?
YES NO RESOLVED, that the Board of Education of the Wyoming Central School District is hereby authorized to withdraw from the existing "2020 Vehicle, Machinery, & Equipment Purchase Capital Reserve Fund" a sum of money not to exceed Thirty-Three Thousand dollars (\$33,000), and to expend such funds for the costs associated with purchasing and installing equipment upgrades to the District's phone system.

PROPOSITION #4: Authorization to establish "2025 Vehicle, Machinery and Equipment Purchase Capital Reserve Fund"

Shall the following resolution be adopted?
YES NO RESOLVED, that the Board of Education of the Wyoming Central School District is hereby authorized to establish a capital reserve fund in accordance with New York State Education Law Section 3651 to be known as the "2025 Vehicle, Machinery and Equipment Purchase Capital Reserve Fund".
The purpose of such fund being to finance, in whole or in part, the purchase and installation of vehicles, equipment, machinery or apparatus, furnishings, and costs incidental thereto, including transportation vehicles, (buses and vans), technology equipment (educational and office), buildings and grounds equipment, furnishings, and other equipment, machinery or apparatus incidental thereto or separately; provided that such capital costs are an object of purpose that would be eligible for financing under the Local finance Law.
The ultimate amount of such reserve fund shall not exceed \$500,000, plus earnings thereon. The probable term of such reserve fund shall be 10 years, but such fund shall continue in existence for its stated purpose until the fund is exhausted or otherwise liquidated in accordance with the Education Law.
The source of monies to be paid into such reserve fund shall include: (a) current and future unappropriated fund balance made available by the Board of Education from time to time; (b) any appropriations authorized by the voters from time to time; (c) New York State Aid received and made available by the Board of Education from time to time; and (d) fund balances transferred from other reserve funds of the District, all as authorized by law.
PROPOSITION #5: Authorization to establish "2025 Building Capital Reserve Fund"
Shall the following resolution be adopted? YES NO RESOLVED, that the Board of Education of the Wyoming Central School District, Wyoming County, New York, is authorized to establish a capital reserve fund in accordance with New York State Education Law Section 3651 to be known as the "2025 Building Capital Reserve Fund".
The purpose of such fund shall be used to finance, in whole or in part, the construction, reconstruction, additions, alterations, renovations, and improvement of school buildings and facilities and the acquisition and installation of machinery, equipment, apparatus, or furnishings and costs incidental thereto, such capital costs being of a type that would be eligible for financing under the Local Finance Law.
The ultimate amount of such fund shall not exceed Eight Hundred Fifty Thousand Dollars (\$850,000) plus earnings thereon. The probable term of such reserve fund shall be 10 years, but said fund shall continue in existence for its state purpose until the fund is exhausted or otherwise liquidated in accordance with the Education Law.
The source of monies to be paid into such reserve fund shall include: (a) current and future unappropriated fund balance from the General Fund of the district as directed by the Board of Education; (b) any appropriations authorized by the voters from time to time; (c) New York State Aid received and authorized by the Board of Education; and (d) fund balances transferred from other reserve funds of the District, as authorized by law.
PROPOSITION #6: Wyoming Free Circulating Library Association
Shall the following resolution be adopted? YES NO RESOLVED, shall the sum raised by annual levy of a tax upon the taxable real property within the Wyoming Central School District for the purpose of funding a portion of the operating expenses of the Wyoming Free Library Association be increased by Two Thousand dollars (\$2,000,00) from the annual amount of Forty-Five

Thousand Four Hundred Ninety-Five dollars (\$45,495.00) to the annual amount of Forty-Seven Thousand Four Hundred

Ninety-Five Dollars (\$47,495.00) commencing with the 2025-2026 school year?

What is the Three-Part Budget?

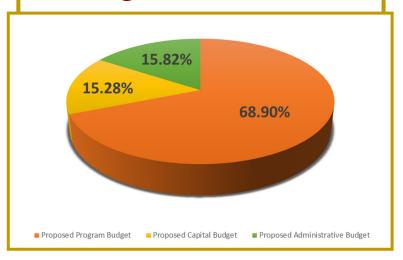
New York State law requires that all school districts present the proposed budget in three parts: Program, Capital and Administrative. The law also states that the Three-Part Budget must exclude any propositions or voter-authorized adjustment.

The Program component of the proposed budget includes expenses associated with our instructional program, teacher salaries and benefits, transportation costs, special education, legal services, and community services.

The Capital component contains building and grounds, maintenance, custodial services, utilities, administrative services, tax refunds and judgments, capital expenses, and debt services.

The Administrative component includes costs associated with running the Superintendent's/Principal's Office, Board of Education expenditures, finance/legal services, and personnel.

A resident of the school district for at least 30 days prior to the voting date.

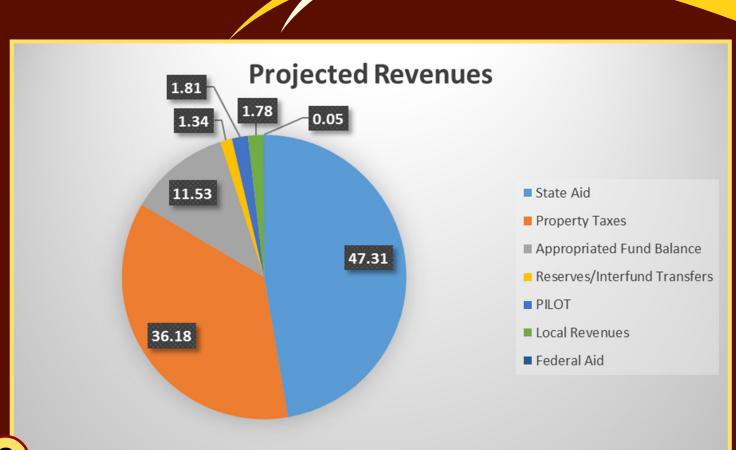

The completed applications must be received by the District Clerk at least seven days prior to the election if the ballot is to be mailed, or the day before the election if the ballot is to be issued in person.

The District Clerk must receive completed absentee and early voting ballots no later than 5:00 pm on Tuesday, May 20, 2025.
