FRESNO UNIFIED SCHOOL DISTRICT SUPERINTENDENT EMPLOYMENT AGREEMENT

This Employment Agreement ("Agreement") is made and entered into by the Board of Education of the Fresno Unified School District ("District" or "Board") and Mao Misty Her ("Superintendent") (collectively, the "Parties") on the terms and conditions below.

1. **Term.** District hereby employs Superintendent for a period beginning on May 1, 2025, and terminating on June 30, 2028, unless terminated earlier or extended as provided by the terms of this Agreement or as allowed by law. Should the Superintendent receive a positive evaluation pursuant to this Agreement, the Board shall place on the next regularly scheduled Board meeting following the Superintendent's positive evaluation, an agenda item for discussion and approval of a one-year extension of this Agreement. This shall not be considered an automatic extension of term as the Board must first (1) have provided the Superintendent with a positive evaluation and (2) the extension must have been approved at a regularly scheduled Board meeting.

2. **Salary**

a. **Salary.** The superintendent's annual salary shall be Three Hundred Eighty-Five Thousand Dollars (\$385,500.00), which includes the 7.5% career increment. For the 2024-25 school year, the Superintendent's annual salary shall be prorated.

b. **Salary Increases.**

1) **General Provisions.** The Board reserves the right to increase the Superintendent's salary, as stated in 2.a., at any time during the term of this Agreement so long as such increase is approved by the Board in open session at a regular meeting of the Board. Any change in salary shall not extend the term of this Agreement and shall not constitute creation of a new agreement. The Parties intend to comply with all applicable laws.

2) **Consistent Salary Increases.** Having the goal of providing the Superintendent with consistent salary increases in accordance with CALSTRS Creditable Compensation Guidelines adopted January 2015, and in an effort to maintain parity with other District certificated personnel, the Superintendent, upon having been given a positive evaluation, shall receive an increase to the Superintendent's salary in the range of 3% -7%, in the Board's determination, beginning July 1, 2026 and each July 1 thereafter for the term of the Agreement including extensions of the Agreement.

c. **Salary Payment Process.** The Superintendent's total salary shall be payable in approximately twelve (12) equal monthly payments, less all applicable deductions and withholdings required by law or authorized by the Superintendent. Salary increases shall be effective on any date ordered by the Board.

d. **Adjustments to Annual Salary.** During the term of this Agreement, the superintendent's annual salary as set forth in 2.a, above, shall be increased or decreased by a percentage equal to the percentage increase or decrease applied to the salary schedule for management employees generally. Any such increase or decrease in the Superintendent's annual salary shall take effect on the same date as the increase or decrease to all management salary

schedules, unless otherwise ordered by the Board. As set forth in section 2.b.1, any adjustment in Superintendent's annual salary made during the life of this Agreement shall be approved by the Board in open session at a regular meeting by a revision to the salary schedule specifically applicable to the Superintendent. Nothing in this subsection shall preclude additional salary increases as stated in 2.b.1.

e. **One-Time Off Salary Schedule Payments.** The Superintendent shall receive one-time, off salary schedule payments in the same amount and paid in the same manner as any one-time, off salary schedule payments made to management employees generally including 2.5% of annual salary for 2025-2026.

3. **Fringe Benefits and Work Year.**

a. **Health Benefits.** As an active employee, the Superintendent shall be eligible to participate in the District's health and welfare benefit program on the same terms and conditions, and subject to the same limitations, as the District's certificated management staff, as those benefits, costs, plans, providers and other terms and conditions may change from time-to-time. Thus, the Superintendent shall be entitled to receive the same District contribution toward health and welfare benefits and shall pay the same co-pays, premiums, deductibles and other costs as the District's certificated management staff, as those costs and contributions may change from time-to-time.

b. **Retiree Health Benefits.** The Superintendent, having served in the District for thirty-one (31) years, has fulfilled the requirements for receiving lifetime health benefits. Should the Superintendent separate from the District either voluntarily or by Board action before reaching the age of fifty-seven and a half, she shall have full right and entitlement to obtain lifetime health benefits from the District.

c. **Sick Leave.** The Superintendent shall earn one (1) day of sick leave with pay for each full month of service rendered during the term of this Agreement. Time off required by the Superintendent for illness or injury that is not compensated by sick leave, vacation leave, or other leave provided by law shall remain uncompensated. The Superintendent shall have all rights to her accumulated sick leave as per Education Codes 44979-44980. The Superintendent shall follow District procedures and use District forms or applicable electronic reporting systems for reporting use of sick leave.

d. **Business and Auto Expenses.** The District shall provide the Superintendent an expense allowance of \$1,500.00 per month for the payment of reasonable actual and necessary automobile expenses incurred for travel within Fresno County and business-related expenses incurred by the Superintendent in the course and scope of the Superintendent's employment. The Superintendent shall not be reimbursed for any expenses above this amount, as described herein, unless such other expenses are specifically provided for in this Agreement. The Superintendent shall not be required to provide receipts or other documentation for the expenses incurred under this section 3.d

e. **Vacation.** The Superintendent shall be entitled to twenty-five (25) days of annual vacation. Vacation may be earned and accrued, from year to year, but the accrual maximum shall not, in any event or circumstances, including any District custom or practice, exceed forty (40)

days of vacation. The Superintendent shall have the option to be compensated for up to a maximum of ten (10) days of accrued vacation in each school year on the express condition that the Superintendent provides the Board President and Human Resources with written notice of her decision to exercise this option by no later than June 1st of each school year.

The Superintendent's entitlement to vacation days shall be accrued on a month-to-month basis. Upon termination of employment with the District, the Superintendent shall be entitled to compensation for unused and accrued vacation days at the then existing daily rate, which shall not exceed the maximum accrual of forty (40) days at the then current salary rate. The Superintendent shall report use of vacation to Human Resources and the Board President and shall notify the Board President in advance of her vacation plans beyond three (3) days. The Superintendent shall plan her vacations to avoid disruption of the discharge of her duties during the school year. The Superintendent shall provide an annual report to the members of the Board of her use of vacation days and all forms of authorized leave, including sick leave, by no later than August 31 of each year. Failure to submit the annual report shall suspend further accrual of vacation days until the report is submitted.

f. **Work Year.** Notwithstanding any Board Policy or Administrative Regulation, the Superintendent shall render twelve (12) full months of full-time service to the District each year of this Agreement. Her workdays shall be 225 days for each year of the term of this Agreement. Although the Superintendent is entitled to vacation per section (e) above, sick leave, and District-wide holidays, as the chief executive officer of the District, urgent or exigent circumstances may require addressing issues which occur notwithstanding such leave or holidays. The Superintendent shall focus her professional time, ability, and attention on the District's primary mission of educating the students of the District.

4. **Tax Deferred Compensation Plans.** The Superintendent may participate in any tax deferred compensation plans of the District for which she is eligible. All contributions to such plans will be paid by the Superintendent from her salary and shall conform to all requirements of law. In addition to the Superintendent's annual salary as specified above, the District shall also contribute to the Superintendent amounts equal to the maximum annual employee elective deferral allowed under the Internal Revenue Code for both a 403(b) Tax Sheltered Annuity and a 457(b) Tax Sheltered Annuity and shall include any catch-up contribution for employees aged 50 or older. Said contributions to the Superintendent shall be made as monthly installments to commence as of May 1, 2025.

5. **District Technology Devices.** The District shall provide to the Superintendent, in the District's sole discretion, a District-owned laptop computer, tablet or other wireless email device and a smart phone (each a "Technology Device") and shall pay reasonable costs associated with the use and maintenance of all Technology Devices. The Superintendent shall use all Technology Devices in accordance with all the District Policies and all legal requirements. All Technology Devices provided by the District are the property of the District and the District shall have the sole right to control access to and use of Technology Devices through its Policies and law. The Superintendent agrees to sign all technology use agreements or other forms that are required of other District employees. Notwithstanding any District Policy to the contrary, the Superintendent agrees to conduct all District business, whether by email, text or otherwise, on a District Technology Device or, if the Superintendent conducts District business on a private

device, through a District account, so that all communications related to the District's business shall be available to the Chief Technology Officer irrespective of the form of communication. All such Technology Devices, and any other equipment or property of the District, shall be returned to the District upon cessation of employment.

6. **Travel Expense.** In accordance with District policies, the District shall reimburse the Superintendent for actual and necessary expenses incurred by the Superintendent within the course and scope of the Superintendent's employment for travel and related expenses beyond a 60-mile radius of the District's boundaries, which shall not be considered included within the business or auto expense allowance as set forth in section 3.d.

7. **Fitness for Duty Examination.** Upon request, the Superintendent shall undergo a physical/mental examination by a District-appointed physician. Prior to the examination, the Superintendent agrees to execute District-provided medical releases from all treating physicians authorizing the District-appointed physician to review all medical records. The District-appointed physician shall review this Agreement, the District's job description for the position, and be provided background information related to the duties of the position. The Superintendent shall submit all costs associated with this examination to the Superintendent's insurance carrier. All non-insured costs shall be borne by the District. The physician shall submit a confidential written report to the Board and the Superintendent addressing only the Superintendent's fitness to perform the Superintendent's job.

The physician's report shall specifically indicate whether or not the Superintendent has any physical or mental impairment that substantially limits the Superintendent's ability to perform the essential functions of the Superintendent's position. No confidential medical information shall be submitted to the Board, the District, nor to any third party, or any of the District's officers, agents or employees unless such medical information is directly related to determining whether the Superintendent is a qualified individual with a disability, or the Parties need to discuss reasonable accommodation. If the Superintendent is determined by the District to be a disabled employee under state or federal law, the physician's report shall indicate what reasonable accommodations, if any, may be available to allow the Superintendent to perform the essential functions of the position.

8. **Superintendent's Duties.** The Superintendent shall competently and satisfactorily perform the representative duties as described in Superintendent Job Description, approved by the Board on July 28, 2010, shall perform those duties as specified in Education Code section 35035, and such other duties as may be directed by the Board or required by law. The Superintendent has primary responsibility for overseeing the District's personnel system. The Superintendent shall nominate all personnel hired for positions at level E-27 and above and the Board shall approve those persons so recommended. If a nomination by the Superintendent is not acceptable to the Board, the nomination shall be withdrawn. The Superintendent or designee shall then present other nominations to the Board for consideration. Regardless of any Board Policy, regulation, or job description to the contrary, the Superintendent shall inform the Board of any promotion, demotion, transfer, and reassignment of employees at level E-27 and above.

9. **Professional Development and Affiliations.** The Superintendent shall endeavor to maintain and improve Superintendent's professional competence by a variety of means. Prior approval of the Board shall be obtained if the Superintendent desires to attend meetings outside

the State of California. District agrees to pay the Superintendent's membership fees for the Association of California School Administrators ("ACSA"), the membership fees for California Association of Asian & Pasifika Leaders in Education (CAAPLE) and the dues (excluding fines, meals and other non-dues costs) for a local Rotary Club within the District. Travel and lodging expenses shall be reimbursed for attendance at the ACSA annual Superintendents' Symposium and for attendance at the California School Boards' Association ("CSBA") annual conference in accordance with the Board's Policies and Regulations. Attendance at any other conferences in California shall be subject to prior approval by the Board President. Attendance at any conferences outside California shall be subject to prior approval by the Board.

10. **Evaluation of Superintendent.**

a. **Annual Written Evaluation.** The Board shall evaluate the Superintendent in writing each year of this Agreement. The evaluation shall be based on this Agreement, the duties of the position, policy goals for the District, and other goals and objectives mutually established by the Board and the Superintendent. The Board and the Superintendent shall mutually establish the evaluation instrument and metrics by which to evaluate the Superintendent. The Board shall finalize determination of the goals, objectives and timeline for the evaluation. The initial annual evaluation shall be completed by May 30, 2026, and, in each subsequent year by May 30, unless otherwise agreed to by the Board and the Superintendent. At the conclusion of each year's evaluation, the Board shall state, in writing, on the Superintendent's evaluation form, whether or not the evaluation is "positive", if approved by a majority of votes, so that a clear and affirmative decision is made regarding the Superintendent's entitlement to the salary increase specified in section 2.b.

b. **Other Evaluations.** Nothing shall prevent the Board from conducting more than one formal or informal evaluation each school year.

c. **Board Review.** The Board shall complete the evaluation instrument. Upon completion, the Board shall meet with and provide a copy of the evaluation report to the Superintendent in closed session as required by law. Based upon findings specified in the evaluation report, the Superintendent, in collaboration with the Board, will prepare an action plan, if necessary, which will address areas identified as needing clarification, emphasis or improvement. The action plan shall identify in writing areas where improvement is required and provide written recommendations for improvement. If a jointly prepared action plan cannot be agreed upon, the action plan shall be issued by the Board in its sole discretion. The Superintendent and the Board shall sign the evaluation report and action plan. Any final evaluation and all related documents shall be placed in the Superintendent's personnel file.

d. **Failure to Evaluate Non-Limiting.** The evaluation procedures and requirements set forth in this Agreement shall be the exclusive means by which the Superintendent is evaluated and are intended to supersede any other provisions covering evaluation that might exist in applicable law or by virtue of any District rules, regulations, handbooks, policies or other agreements. Any failure on the part of the Board to meet the requirements or deadlines set forth in this Agreement shall not release the Superintendent from fully and faithfully performing the services required to be performed under this Agreement or constitute a default by the District of its obligations under this Agreement.

e. **Outside Facilitator.** Whenever it is deemed desirable by the Board, an outside facilitator may be selected by the Board to facilitate discussion of the relationship between the Board and Superintendent. The outside facilitator shall be paid by the District. The outside facilitator shall maintain the confidentiality of the evaluation process.

11. **Termination of Agreement.**

a. **Mutual Consent.** This Agreement may be terminated at any time by mutual written consent of the Board and the Superintendent.

b. **Resignation.** The Superintendent may resign and terminate this Agreement only by providing the Board with at least ninety (90) calendar days advance written notice, unless the Parties agree otherwise.

c. **Non-Renewal of Agreement by the District.** The Board may elect not to renew this Agreement upon its expiration by providing written notice to the Superintendent in accordance with Education Code section 35031 (currently forty-five (45) calendar days' prior notice), or other applicable provisions of law. The Superintendent shall inform the Board President of this notice requirement at least ninety (90) calendar days in advance of expiration of this Agreement. Accordingly, notwithstanding anything to the contrary in Education Code section 35031 or other applicable provisions of law, the Parties agree that, if the Board fails to reelect or reemploy the Superintendent and a written notice of non-renewal is not timely provided, this Agreement shall be renewed only for one (1) additional school year (April 30- April 29) under the same terms and conditions as this Agreement that existed in the school year immediately prior to renewal.

d. **Termination for Cause.** The Board may terminate the Superintendent for any of the following reasons: (1) breach of this Agreement; (2) failure, based on unsatisfactory performance, to achieve measurable goals, plans, priorities and objectives of the District which have been mutually agreed on by the Board and Superintendent and finally determined by the Board; (3) refusal or failure to act in accordance with a specific provision of this Agreement or a lawful directive or order of the Board; (4) misconduct or dishonest behavior with regard to the Superintendent's employment; (5) conviction of a crime involving dishonesty, breach of trust, physical or emotional harm to any person, or a violation of moral turpitude; (6) any act causing the suspension or revocation of any credential held by the Superintendent; or (7) any reason specified in Education Code section 44932. Notwithstanding Labor Code section 2924, the Parties agree that the determination of cause shall be based upon the Board's reasonable belief in the existence of good cause for termination. The existence of such cause shall constitute a material breach of this Agreement and shall extinguish all rights and duties of the Parties under this Agreement. If cause exists, the Board shall meet with the Superintendent and shall submit a written statement of the grounds for termination and copies of written documents the Board reasonably believes supports the termination. If the Superintendent disputes the charges, the Superintendent shall then be entitled to a conference before the Board in closed session. The Superintendent and the Board shall each have the right to be represented by counsel at their own expense. The Superintendent shall have a reasonable opportunity to respond to all matters raised in the charges and to submit any written documents the Superintendent believes are relevant to the charges. The conference with the Board shall not be an evidentiary hearing and neither Party shall have the opportunity to call witnesses. If the Board, after considering all information

presented, decides to terminate this Agreement, it shall provide the Superintendent with a written decision. The decision of the Board shall be final. The Superintendent's conference before the Board shall be deemed to satisfy the Superintendent's entitlement to due process of law and shall be the Superintendent's exclusive right to any conference or hearing otherwise required by law. The Superintendent waives any other rights that may be applicable to this termination for-cause proceeding with the understanding that completion of this hearing exhausts the Superintendent's administrative remedies and then authorizes the Superintendent to contest the Board's determination in a court of competent jurisdiction.

e. **Termination without Cause.** Notwithstanding any other provision of this Agreement, The Board, without cause, in its sole discretion, shall have the option to unilaterally terminate the Agreement upon the provision of written notice of such termination to the Superintendent. The board must provide the Superintendent with a minimum of ninety (90) days written notice when unilaterally terminating the Superintendent. If the Board elects the option to terminate this Agreement without cause, then the Superintendent shall receive the Superintendent's salary for the remainder of the Term of the Agreement, or twelve (12) months, whichever is less (Gov. Sode 53260) Any such termination shall be in writing, shall specify the effective date of the termination, and shall terminate all the Superintendent's employment rights and entitlements with the District. The Superintendent shall execute a full release of claims against the District and its officers, agents and employees as a condition of receipt of any severance payment; otherwise, no severance payments shall be required, and termination shall be effective, nevertheless.

For purposes of this Agreement, the term "salary" shall include only the Superintendent's regular monthly salary and shall not include the value of any other stipends, allowances, reimbursements or benefits, received under this Agreement. Payment shall be made for any accrued and unused vacation up to the maximum accrual limit set forth in section 3.e. up to the date of termination and shall not, in any event, accrue after the date of termination. All payments made pursuant to this termination without cause provision shall be subject to applicable payroll deductions and shall be treated as compensation for state and federal tax purposes. No payments made pursuant to this early termination provision shall constitute creditable service or creditable compensation for retirement purposes since the payments are considered as final settlement pay; accordingly, no deductions shall be made for retirement purposes.

In addition to the salary payments specified above, but only to the extent 3.b. for any reason does not apply, the District agrees to continue to provide the Superintendent with its contribution toward District health benefits and to allow the Superintendent to participate in the District's health benefit program on the same terms and conditions that existed prior to termination until the expiration of this Agreement, or for a period of twelve (12) months, or until the Superintendent obtains other employment that provides health benefits, whichever is less. As a condition of receipt of health benefits, the Superintendent shall pay all required premiums in advance and comply with all other conditions imposed by law and/or the District's benefit providers. If the Superintendent elects to retire in lieu of receiving payments under this section, the Superintendent shall be entitled to any health benefits in accordance with the provisions of section 3.b.

The Parties agree that any damages to the Superintendent that may result from the Board's early termination of this Agreement cannot be readily ascertained. Accordingly, the Parties agree that the payments made pursuant to this termination without cause provision, along with the District's agreement to provide any paid health benefits other than 3.a., constitutes reasonable liquidated damages for the Superintendent, fully compensates the Superintendent for all tort, contract and other damages of any nature whatsoever, whether in law or equity, and does not result in a penalty. The Parties agree that the District's completion of its obligations under this provision constitutes the Superintendent's sole remedy to the fullest extent provided by law. Finally, the Parties agree that this provision meets the requirements governing maximum cash settlements as set forth in Government Code sections 53260, et seq. The District having settled the damages caused to the Superintendent for damages terminating the Superintendent without cause, and the Superintendent having relinquished all claims against the District, both Parties shall no longer have any obligations to the other beyond the date of termination.

f. **Termination for Unlawful Fiscal Practices.** Notwithstanding any other provision of this Agreement to the contrary, if the Board believes, and subsequently confirms through an independent audit, that the Superintendent has engaged in fraud, misappropriation of funds, or other illegal fiscal practices, then the Board may immediately terminate the Superintendent solely upon written notice to the Superintendent and the Superintendent shall not be entitled to any compensation of any nature, whether as cash, salary payments, or other non-cash settlement as set forth above. This provision is intended to implement the requirements of Government Code section 53260(b).

g. **Death.** Death of the Superintendent terminates the Agreement immediately. In such event, all salary and other monetary amounts due to the Superintendent at the time of death, if any, shall be paid to the Superintendent's estate unless otherwise declared in writing by the Superintendent.

h. **Disability of the Superintendent.** If, based on medical evidence submitted by the Superintendent's physicians or obtained through a District required medical examination, the District determines that the Superintendent is disabled and, following an interactive dialogue with the Superintendent, that the Superintendent is unable to perform the essential functions of the position with or without reasonable accommodation, this Agreement may be immediately terminated by the Board upon written notice to the Superintendent in the manner required by law. Disability shall not entitle the Superintendent to the provisions of section 11.e.

12. **Tax/Retirement Liability.** Notwithstanding any other provision of this Agreement, the District shall not be liable for any retirement or state/federal tax consequences to the Superintendent, or to any designated beneficiary, heirs, administrators, executors, successors or assigns of the Superintendent. The Superintendent shall assume sole responsibility and liability for all state or federal tax and retirement consequences of this Agreement, to the extent permitted by applicable law, and all related payroll and retirement consequences, including, but not limited to, whether compensation or service is creditable for purposes of retirement, all tax and retirement consequences stemming from any payments made to the Superintendent as a result of the termination without cause provision of this Agreement, retirement payments, expense reimbursements, and payments for insurance.

13. **Abuse of Office Provisions.** In accordance with 'Government Code section 53243, et seq., and as a separate contractual obligation, should the Superintendent receive a paid leave of absence or cash settlement if this Agreement is terminated with or without cause, such paid leave or cash settlement shall be fully reimbursed to the District by the Superintendent if the Superintendent is convicted of a crime involving an abuse of the Superintendent's office or position. In addition, if the District funds the criminal defense of the Superintendent against charges involving abuse of office or position and the Superintendent is then convicted of such charges, the Superintendent shall fully reimburse the District all funds expended for the Superintendent's criminal defense.

14. **Notification by Superintendent Prior to Accepting Other Employment.** If the Superintendent decides to accept employment elsewhere during the term of this Agreement, prior to doing so, the Superintendent shall notify the Board in writing of her decision. In addition, the Superintendent shall immediately notify the Board in writing if the Superintendent becomes a finalist for employment outside the District.

15. **Indemnity.** In accordance with the provisions of Government Code sections 825 and 995, the District agrees to defend the Superintendent against any claim or action against him for an injury arising out of an act or omission occurring within the scope of his employment as the Superintendent of the District. Nothing herein shall be construed to limit or expand the rights, duties, and obligations of the District and the Superintendent which are provided under these Government Code sections, including any subsequent amendments. Upon separation or retirement from the District, the Superintendent will continue to be indemnified for any actions taken against her related to her role as the Superintendent of the Fresno Unified School District.

16. **General Provisions.**

a. **Governing Law Venue.** This Agreement, and the rights and obligations of the Parties, shall be construed and enforced in accordance with the laws of the State of California. Venue for court proceedings shall be in Fresno County, California.

b. **Entire Agreement.** This Agreement contains the entire agreement and understanding between the Parties. There are no oral understandings, terms or conditions and neither Party has relied upon any representation, express or implied, not contained in this Agreement.

c. **Notification of Absence.** If the Superintendent plans on being absent from the District for more than three (3) continuous workdays, the Superintendent shall notify the Board President in advance.

d. **No Assignment.** The Superintendent may not assign or transfer any rights granted or obligations assumed under this Agreement.

e. **Modification.** This Agreement cannot be changed or supplemented orally. It may be modified or superseded only by a written instrument executed by both Parties.

f. **Exclusivity.** The Parties agree that the employment relationship between the District and the Superintendent shall be governed exclusively by the provisions of this Agreement

and not by Board Policies, administrative regulations, job description or similar documents, unless such policies, regulations or similar documents are specifically referenced in this Agreement. To the extent any policy, administrative regulation, or job description of the Superintendent, or similar document, is inconsistent with the provisions herein, this Agreement shall govern and supersede any such provisions.

g. **Management Hours.** The Parties recognize that the demands of the position will require Superintendent to average more than eight (8) hours a day and/or more than forty (40) hours per week. The Parties agree that Superintendent shall not be entitled to overtime compensation.

h. **Construction.** This Agreement shall not be construed more strongly in favor of or against either Party regardless of which Party is responsible for its preparation.

i. **Execution of Other Documents.** The Parties shall cooperate fully in the execution of any other documents and in the completion of any other acts that may be necessary or appropriate to give full force and effect to this Agreement.

j. **Independent Review.** The Parties have had the opportunity to obtain, and have obtained, independent legal or other professional advice with regard to this Agreement, including tax and retirement consequences. The Superintendent and the Board each recognize that in entering into this Agreement, the Parties have relied, or have had the opportunity to rely, upon the advice of their own attorneys or other representatives.

k. **Binding Effect.** This Agreement shall be for the benefit of and shall be binding upon all Parties and their respective successors, heirs, and assigns.

l. **Execution.** This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. A copy, facsimile, photographic copy or an original, with all signatures appended together, shall be deemed a fully executed Agreement and shall be as valid as an original for any purpose. In addition, this Agreement may be signed in person or electronically and such signatures shall be binding.

m. **Savings Clause/Severability.** If any provision of this Agreement or its application is held invalid; the invalidity shall not affect the other provisions or applications of the Agreement that can be given effect without the invalid provisions or applications and the provisions of this Agreement are declared to be severable.

n. **Public Record.** The Parties recognize that, once final, this Agreement is a public record and must be made available to the public upon request.

o. **Integration.** This Agreement constitutes a complete and exclusive statement of the understanding between the Parties with respect to its subject matter. This Agreement supersedes any and all other prior communications between the Parties, whether written or oral. Any prior agreements, promises, negotiations or representations related to the subject matter not expressly set forth in this Agreement are of no force and effect.

p. **Waiver.** Any waiver of any breach of any term or provision of this Agreement shall be in writing and shall not be construed to be a waiver of any other breach of this Agreement.

q. **Board Approval.** The effectiveness of this Agreement shall be contingent upon approval by the District's Board as required by law.

- Life Skills: The percentage of 6th, 8th, and 12th grade students who demonstrate benchmarked competencies in the skills listed in the Portrait of a Learner using age-appropriate assessments will increase by X% in June 2027 to Y% by June 2030.

- Effective Staff: The superintendent will not allow the hiring, promotion, or lateral movement of staff who are performing "does not meet standard" as defined by CPSELs, CSTPs, and classified standards.
- Health & Wellness: The superintendent may not meet the goals at the cost of unreasonably compromising the health and wellness of students and staff.
