The non-homestead tax vote can be confusing. Read on....

What are we voting for?

- Renew the operating millage of the school district.
- Renew the 18 mills levied on non-homestead property (i.e.; industrial, commercial, business, rental and second homes).
- This is is <u>not</u> a new tax.
- This tax does <u>not</u> affect homeowners on their primary residence.
- The ballot language asks the voters to approve 19.4672 mills for a period of six years. However, the district <u>cannot</u> levy more than 18 mills.
- The additional millage will allow the district to levy the full 18 mills in future years if the millage rate is adjusted due to property values increasing greater than the rate of inflation.

If approved, how much will the proposal cost me each year?

Approval of the millage proposal will cost homeowners **nothing**. If you own a second home or business property, you will continue to pay the same 18 mills that have been levied since the passage of Proposal A in 1994. There will be **NO INCREASE** in your taxes for this levy.

What is the money used for?

The millage is for operating expenses and allows White Pigeon Community Schools to receive our revenue per pupil guarantee from the State of Michigan. If the millage is approved, the school district will collect 4.2 million dollars in 2025 for operating expenses. This is not new money, just a continuation of current funding.

Wasn't there a bond and sinking fund recently passed?

Yes. The operating millage is unrelated to bond and sinking funds. Bond and sinking funds can **ONLY** be used for building/site improvements, construction, and equipment and **CANNOT** be used for operating purposes.

What is the legal wording of the proposal?
