Sealed bids are due on or before 3:00 p.m., June 24, 2025, at the District Office. At this time bids will be opened and publicly read aloud. Any claim of Bidder error must be made in compliance with Public Contract Code § 5100, et seq. The District is not responsible for bids received after the deadline or misdelivered even if to a different District address.

The Project consists of: Interior remodel of an existing administration building.

Bids shall be on the form provided by the District. Bids must conform and be responsive to all pertinent Contract Documents.

Bidders are required to possess the following State of California Contractor Licenses: B

Bidders shall provide with their Bid form an acceptable bid security in the amount of ten percent (10%) of the total bid price. This bid security shall be a guarantee that the Bidder shall, within seven (7) calendar days after the date of the Notice of Award, enter into a contract with the District for the performance of the services as stipulated in the bid.

The successful Bidder must furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Project.

The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of Public Contract Code § 22300.

The successful Bidder and its subcontractors shall pay all workers on the Project not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to Labor Code § 1770 et seq. Prevailing wage rates are on file with the District and are available to any interested party on request or at **www.dir.ca.gov/oprl/statistics_and_databases.html**. Bidders and Bidders' subcontractors shall comply with the registration and qualification requirements pursuant to Labor Code §§ 1725.5 & 1771.1

A mandatory pre-bid conference/job-walk will be held on June 10, 2025 per the instructions included in the bid.

The District's Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful Bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no Bidder may withdraw its bid for ninety (90) days after the date of the bid opening.

The District shall award the Contract, if it awards it at all, to the lowest responsive responsible Bidder(s) based on the low base bid without consideration of bid alternates.
