Acknowledgement Concerning Use of Student Parking Lots

Student Initial	Students are permitted to park on school premises as a matter of privilege, not of right. Driving a vehicle on school property is regulated by state law and school district policy. Students should drive in a safe manner in order to maintain the privilege of driving to school. Students will adhere to school regulations regarding speed limits, posted signs, designated parking areas (including staff and visitor parking areas), closed campus policy, etc. Students in violation of the rules and regulations, <i>including CSHS Attendance Policies</i> , will be subject to disciplinary action and may have their parking privilege suspended or revoked. Vehicles and students not in compliance with the parking rules and regulations will be identified and the student may be subject to disciplinary action and/or lose parking privileges. Students who leave campus during school hours without permission will be subject to disciplinary action and may lose parking privileges.
Student Initial	Any student parking on campus must process and have approval through the Assistant Principal, RJ Morgan, upon submission of all required family documents listed below. Due to the limited availability of student parking spaces, priority shall be given to seniors, then juniors; there is limited sophomore space available. Any student in possession of a permit not registered to them or in possession of a counterfeit pass, will be subject to disciplinary action and may lose parking privileges. Students are required to park in their assigned student parking lot; students will not have the option of changing lots once their parking permit has been issued without administrative approval. Students will NOT be allowed to go to their vehicle during the school day without permission. Placards are not transferable .
Student Initial	The Cave Creek Unified School District (CCUSD) retains authority to conduct routine patrols of student parking lots and inspections of the exteriors of students' vehicles on school/district property. The authorities of the school district may inspect the interiors of student's vehicle whenever a school authority has reasonable suspicion that illegal or unauthorized materials are contained inside the vehicles. Such patrols and inspections may be conducted without notice, without the student's consent and without a search warrant. Students who fail to provide access to the interior of their vehicle upon request by a school official will be subject to disciplinary action
Student Initial	Students will not be allowed to go to their vehicle during the school day without permission. Improper driving or parking of a vehicle on school property without permission and/or parking in prohibited areas can result in disciplinary consequences and fines. Accessing a car or the parking area during the school day without express permission can result in disciplinary consequences.
Student Initial	The vehicle must display a valid parking placard on their rearview mirror and be visible at all times. CCUSD and CSHS are not responsible for permit replacement; a replacement fee of \$25 may be required. Parking permit fees will NOT be refunded.
Student Initial	CCUSD and CSHS assume no liability for student vehicles damaged by vandalism or accidents while parked on district property.
