For the 2025-2026 school year, LEAs must continue reporting **2024-2025 leavers** in the **2025-2026 Fall PEIMS Submission** as usual.

However, a new reporting requirement has been introduced for **2025-2026 leavers**:

- **NEW:** Students will be reported in the **2025-2026 Summer PEIMS** and **Extended Year PEIMS**, with resubmission opportunities to ensure accuracy.
- **Current-year leavers (2025-2026)** must be monitored weekly to verify and maintain accurate records.

This change highlights the importance of continuous leaver verification throughout the school year.

Beginning in the **2026-2027 school year**, a **new change** for LEAs will take effect regarding **leaver reporting**:

- **Leavers will be reported in the 2026-2027 Summer PEIMS and Extended Year PEIMS**, with resubmission opportunities for corrections.
- **Students will also be reported in the 2026-2027 Summer PEIMS and Extended Year PEIMS**, allowing LEAs to verify accuracy through resubmissions.
- **Current-year leavers (2026-2027) must be monitored weekly** to ensure validity and accuracy.

This update emphasizes the importance of continuous leaver verification to uphold data integrity.

Starting in the **2027-2028 school year**, a **new leaver reporting process** will take effect:

- **Leavers will be reported in the 2027-2028 Summer PEIMS and Extended Year PEIMS.**
- **PEIMS Resubmissions will NO LONGER be available** for corrections.
- **Students will still be reported** in the 2027-2028 **Summer PEIMS** and **Extended Year PEIMS**, allowing for initial accuracy checks.
- **Current-year leavers (2027-2028)** must be **reviewed weekly** to ensure data accuracy and compliance.

With **no resubmission opportunities**, **continuous monitoring and verification of leaver data throughout the year will be essential.**
