Be it resolved, upon the recommendation of the Superintendent of Schools in conjunction with the Business Administrator/Board Secretary that the following actions be taken:

F1. The Park Ridge Board of Education approves the following budget:

BE IT RESOLVED that the Park Ridge Board of Education, County of Bergen, approves the 2025/26 school year budget as follows:

BE IT FURTHER RESOLVED THAT the Park Ridge Board of Education includes in the final budget the adjustment for increased costs of health benefits in the amount of \$425,050. The additional funds will be used to pay for the additional increases in health benefit premiums.

BE IT FURTHER RESOLVED that included in the general fund appropriations, budget line 620 is a withdrawal from Capital Reserve – Other Capital Projects in the amount of \$1,300,000 for other capital project costs. The total cost of these projects are \$1,300,000 which represents expenditures for construction elements or projects that are in addition to the facilities efficiency standards determined by the Commissioner as necessary to achieve the New Jersey Student Learning Standards.
