Dear Parent/Guardian,

The South Carolina College and Career-Ready Assessment (SC READY) program is a required statewide assessment in English Language Arts (ELA) and mathematics for students in grades 3-8 and science for students in grades 4 and 6. For spring 2025 only, all students in grades 3-8 will participate in a three-part ELA assessment in order to field test items that align to the new ELA standards. The three-part ELA assessment will take place across three days and will consist of ELA Reading Part A, ELA Reading Part B, and ELA Writing, which will include the text-dependent writing (TDW) item. This temporary change in format was designed to combat student fatigue. Field test items will be embedded throughout all parts of the operational ELA assessment. The ELA assessment will be factored into the school's report card rating and students will receive scores and performance levels.

SC READY assessments are untimed, but must be completed during the same school day they are started, unless your student has an accommodation to test a single subject over multiple days. Items on SC READY will include multiple choice, technology-enhanced items, evidence-based selected response, and text-dependent writing. Evidence-based selected responses will require students to read a piece of text or a passage and choose the best answer from answer choices. The text-dependent writing item will require students to read a piece of text or a passage and choose the best answer from answer choices. The text-dependent writing item will require students to read a piece of text or a passage and draw upon that text for their extended written responses. SC READY tests are aligned to state standards and what is taught in your child's classroom. SC READY must be taken in-person even if students are enrolled in full-time virtual/online learning instruction.

In accordance with SC test security law and State Board Regulations, students are prohibited from having any electronic device in their possession during testing. This includes, but is not limited to, cell phones, smart watches, smart glasses, wireless earbuds, and electronic translation devices. All electronic devices will be collected prior to testing by the test administrator for return to the student at the end of testing. Noncompliance with this requirement will result in discipline consequences. This restriction does not apply to electronic medical devices that are documented for use in a student's IEP, 504 Plan, or Individual Health Plan, such as those devices needed for monitoring diabetes as an example.

Transportation for Full-Time Virtual Students

If needed, bus transportation for **full-time virtual students** will be provided on regularly scheduled school days at the published pick-up and drop off times and locations. **If your virtual student requires bus transportation for in-person state testing, please complete a** <u>State</u> <u>Testing Transportation</u> form at least five school days prior to their scheduled test date.

Bus transportation for grades 3-8 full-time virtual students attending through Low Country Virtual will be provided. Families should review the information related to bus stop locations and schedules below. All CCSD bus routes, stop times and locations can be found on the <u>CCSD Transportation</u> web page under the Bus Stop Lookup Tool.

If you believe that there is not a bus stop within 3/10 of a mile from your home, please submit a bus stop request through our <u>School Bus Stop Request Form</u> Bus stops will normally not be added if there is already an existing bus stop within 3/10 of a mile of your home. Magnet School bus stops are different from traditional neighborhood school bus stops. Magnet bus stops are centralized and they could be as far as 5 miles from the home and are considered "parent assisted" bus stops. These Magnet bus stop locations are not intended to be stops to which most students can walk to or be left unattended.

Please submit your bus stop request ten (10) days prior to your child's scheduled test date.
