Dooley Director Melissa Laseck, along with GSRP teaching team Andrea Teneyke and Norma Floer shared about the Great Start Readiness Program at Dooley. This free 4-year-old preschool has grown from one classroom to five since 2022. Classes are all day, Monday-Thursday. With the program expansion, they have added an indoor track and climbing wall and an outdoor playground for students to learn gross motor skills. The program focuses on the whole child, including gross motor, fine motor, social/emotional, arts, and academics. Each classroom has two teachers, a lead and an associate. They do all lessons and activities together. They also host parent family meetings throughout the year, invite parents into classrooms and do home visits to ensure all kids are succeeding.
