PLEASE READ CAREFULLY

Electronics

Campers are permitted to bring cell phones/iPods/iPads. All electronics will be collected upon arrival and kept secured in the counselor's room. GSSP is an electronic free program. Devices will only be returned during our "call home" time. The traditional "call home" time is Thursdays after our evening activity (between 8:00-10:00 p.m. EST) starting week 2. If emergency situations pop-up where you need to speak to your child immediately, please contact the summer office (716.652.3450) and we will have your child get in touch with you as soon as possible.

No Computers

Students will have access to the School's computers for emailing use throughout the academic day, so they will have the ability to get in touch with you via email. Five weeks without a computer may help your child more than you know!

No TV's

Well.....it's summer. We do our best to be outside for as much of the day as possible. Computers and televisions hinder social interaction, which is one of the fundamental components of this program. Therefore, televisions are not allowed during the summer program.

Don't expect a call until July 10th

We have learned that the participants in the Summer Program have the most success when we do not let them call home for the first week of the Program. I understand this may be a lot to ask of YOU, but please understand that this provides a much smoother transition for them into the Program. This will help your child understand who they must go to for help while here. The quicker they can learn this, the better it is for them. The Gow School Summer Program offers counseling services. The school counselor provides students with the support they need to develop academically and socially. Counseling is made available in individual settings to help students overcome behavioral problems, deal with personal issues, minimize negative situations with other students, and offer a safe, comfortable, and non-intimidating place to discuss the things on their mind.

The Gow School Summer Program's Counselor is Mr. Brian Zolet, M.A. Mr. Zolet has spent more than 25 years of his career working in many areas of independent schooling, the majority of them at boarding schools for students with dyslexia and/or other language-based learning disabilities.

A NOTE ON CONDUCT AND DRESS

Expectations of conduct and discipline at The Gow School Summer Program are not covered in a policy book. Our approach regarding discipline is humanistic and fair. If a student is exhibiting inappropriate behavior, the Director will meet with him/her individually and the situation will be resolved on a case-by-case basis, taking into consideration the individual circumstances of the student, as well as the welfare of the entire community. Continued and excessive inappropriate behavior will likely result in dismissal from the Summer Program.

Please be aware that students are forbidden to possess weapons, alcohol, drugs (including any type of inhalant) or paraphernalia. If a student is caught with any of these items, he/she will be dismissed. The Gow School is a “smoke free” campus in addition to being a “drug free” school zone. We have a great regard for the health of our community. Accordingly, we do not allow our students (or employees) to use or possess tobacco products. If a student is caught with tobacco products, he/she may be dismissed. If parents are aware of a tobacco or substance abuse problem, it is recommended that they not send their child to The Gow School Summer Program. The mission of The Gow School Summer Program is far too important to our students for us to allow involvement with any of these destructive and counterproductive behaviors.

With regard to the dress code, The Gow School Summer Program is a casual environment. Student’s clothing should be in good repair, of appropriate length, and age appropriate. Undergarments should not be visible. Any clothing that bears an alcohol, sexual related, drug, or paraphernalia theme or contains inappropriate language is not permitted. A one-piece bathing suits are preferred. Two-piece bathing suits are suitable if worn with a covering. Earrings are allowed, but other pierced body areas are not. Students are asked to dress appropriately deemed by camp leadership.
