

#### **Key Result 3**

Redesigning secondary school experiences, informed by student and family choice

#### Measure 3a

Each comprehensive high school will have developed and shared a Case for Change and Journey Plan

#### Measure 3b

The percentage of families participating in their school's redesign process will be 50% or higher



# Success Beyond High School

#### **Key Result 6**

Preparing students for success beyond high school.

#### Measure 6b

Increase the percentage of students who earn an Industry Recognized Credential (IRC) in IRC-eligible courses annually.

#### Measure 6c

Increase the percentage of students in grade 11 reporting hope and confidence in their ability to complete high school and transition to post-secondary paths as measured by favorable responses on select questions of the Career & College section of the Panorama student survey.



## **Postsecondary Success Measures**


#### What Is Direct Enrollment?

Enrolling in a 2- or 4-year college, technical, or trade school within one year of high school graduation.


### **Why It Matters**

Students who enroll right after high school are more likely to stay in school and complete a degree or credential.

## Statewide, direct enrollment increased slightly for the class of 2022 as compared to the class of 2021 due to an increase at CTCs and other two-year institutions



## Highline HS Graduation Year: 2022 31% (n=351 students) enrolled directly to 4-year colleges.

#### To what do we attribute this relative success?

- Strong central office and school team collaboration
- Robust Tier 1 High School and Beyond Planning structure that includes lessons, course planning, exploration, events and family engagement.

### What are ongoing plans for improvement?

- Strengthening system-wide understanding and support for Tier 1 HSBP efforts among school leadership and staff
- Coherence in advising through Horizons

Draft Measure of Implementation	We are making progress when: iReady literacy scores increase, CiHS credit accumulation and grades increase, and our on-track credit tracker for all courses increases

Draft Measure of Implementation	100% of students in Health Careers will identify their healthcare pathway or another pathway to explore through an exhibition of learning each semester.  Proportionate pass rate for all students
Current Data Used to Inform the Goal/Strategy	Student Interviews, Graduation Rates, Postsecondary Direct Enrollment



Draft 25-26 AAP Redesign Goal (measure of impact)	We want our students to grow their postsecondary readiness skills and course preparation so that 95% of students graduate with a pathway (IB, CTE, CIHS, RS, PSSC)
Draft Strategy	<ul> <li>Every student at MRHS is engaged in a minimum of 3 rigorous IB courses.</li> <li>10th grade students engage in 3 IB diploma program experiences to increase knowledge and understanding about their HS pathway.</li> <li>All teachers will be integrating Harvard Project Zero thinking routines into all content areas to provide students at every level access into a rigorous curriculum.</li> </ul>
Draft Measure of Implementation	<ul> <li>-The number and diversity of students enrolled in IB courses, the IB diploma program, and testing</li> <li>-Increased access to college credit in the high school</li> <li>-Students feeling that MRHS prepared them for the future they choose</li> </ul>
Current Data Used to Inform the Goal/Strategy	Past Enrollment Data, Previous IB Testing Data, Postsecondary Direct Enrollment Data, Our Current Growth In IB Course And Diploma Enrollment Due To Our Redesign Pilots
