## ROSSVILLE CONSOLIDATED SCHOOL DISTRICT SCHOOL BOARD MEETING April 8, 2025

The Rossville Consolidated School District Board of Education held its regular meeting on Tuesday, April 8, 2025, at 7:00 p.m. in the Rossville School Library. Board members present included Joe Hufford, Nathan Root, Jentry Pendleton, and Brent Michael. Nathan McCullough was absent. Also in attendance were Superintendent Dr. James Hanna, Mike Hammons, Chad Dennison, Kim Prather, Ryan Prather, Gideon Prather, David Mackey, Katie Mackey, Denver Mackey, Karla Metzler, Alisha Maish, Rylynn Maish, Alexis Simons, Nicole Simons, Nathan Burkle, Dustin Shadbolt, and Cara Cornell.

The meeting began with the Spotlight - a celebration of student achievement, recognizing winners of the James Whitcomb Riley poetry contest. Students Rylynn Maish ("Little Orphant Annie"), Denver Mackey ("The Ole Hay-Mow"), Alexis Simons ("Granny"), and Gideon Prather ("The Raggedy Man") performed their selected poems.

No public comment was entered.

On a motion by Nathan Root, seconded by Jentry Pendleton, the Board approved the minutes of March 4, 2025, regular session meeting, claims 21303 - 21395, payroll claims dated March 14 & 28, 2025, and review of March 2025 financial reports. The motion passed 4-0.

Gabrielle Hamilton submitted her resignation as the Clinton County Joint Services

Revisions to the Clinton County Joint Services Agreement - clarifying that the

Cooperative will assume responsibility for legal expenses related to Joint

Services employees.

A significant discussion was held regarding the condition of the school's outdoor track. Due to deteriorating conditions and long-term weather impact, Dr. Hanna recommended complete resurfacing and renovation of the track, long jump, high jump, and pole vault areas. Tecton Construction Management submitted a proposal with a total cost of \$228,658.50. Dr. Hanna recommended the project be funded using Rainy Day funds.

Preschool Tuition rates were approved for the 2025-2026 school year:

4-5 Year Olds/2<sup>nd</sup> year in program – Five Days per Week - \$425
3-4 Year Olds/1<sup>st</sup> year in program – Three Days per Week - \$275
Application fee for new applicants - \$50.00
Payments are due on the first day of the month for the following monthExample August is due on July 1<sup>st</sup>. If the payment is not received within five business days of the due date a \$25 late fee will be accessed. If the payment on the student's account is not received within ten business days from the due date, the student will be removed from the program.

The Board graciously accepted several donations:

A \$300 donation from Gary and Brenda Spray to the Rossville FFA. A saxophone and clarinet were donated anonymously to the band program.

Resolution for Eventlink's online payment system to pay athletic officials in compliance with guidance from the State Board of Accounts.

Declaration and disposal of surplus and obsolete equipment, including selling a 2010 GMC Cutaway Bus to the Taylor School Corporation for \$1,000.
