# **WHAT IS A SCHOOL**



- **Definition**: A yearly financial plan for a school district.
- **Purpose**: Funds education, staff, facilities, transportation, and programs.
- **Funding Sources**: Local property taxes, state aid, federal aid, and other income.
- Spending Areas: Instruction, support services, administration, buildings, and extracurriculars.
- **Board Role**: Tax revenue must remain within the cap or within cap plus allowances. Total revenues must balance with expenses.
- Oversight: Reviewed by the NJ Department of Education.

  Annually audited by an independent firm hired by the Board.

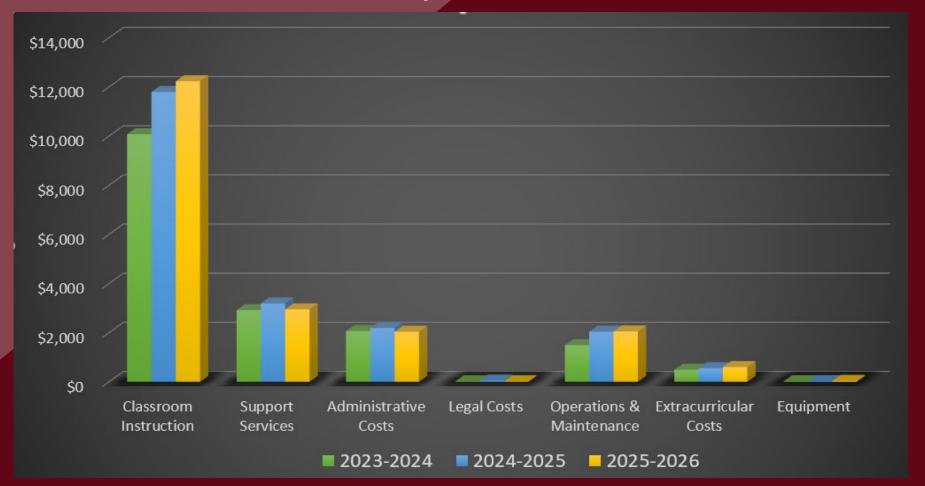


#### **Budget Waivers & Use of Banked Cap**
