The 2017-18 district calendar is attached and recommended for approval. This calendar includes several changes from previous years. These changes include the following:

- Teachers have 4 days in August beginning August 1 for in-service prior to students' first day.
- The second in-service day, August 2, will be a system-wide program for PK-8 teachers.
- First day of school for all students is Monday, August 7 and is a full day.
- Monday, August 21 will be a stockpiled professional development day and will be system-wide day for teachers in grades 9-12.
- Parent-conference day is moved to Wednesday, November 1 since there is no election day in November, 2017.
- There are 2 half-days for professional development at the end of the first and third grading periods, followed by a planning day.
- Exam days in December will be full days for high schools, with the exception of the last day. The last day (December 15) will be a half day for all grades.
- In January, teachers will report for January 2 for a planning day. Students report January 3 to begin the 2nd semester and the 3rd grading period.
- There will be no intersession/snow make-up days scheduled for March.
- The 4th grading period will begin March 29 following a 3 ½ day weekend for students.
