The Grand Forks School Board Teacher Contract Bargaining Committee met on Tuesday, April 29, 2025, at the Mark Sanford Education Center, with Amber Flynn as chairperson.

Call to Order.

The meeting was called to order at 4:16 p.m.

Approval of Minutes.

It was moved by Berger and seconded by Manley to approve the April 22, 2025, minutes, as written. Upon voice vote, the motion carried unanimously.

Executive Session (closed meeting).
