### General Business, Board Reports

- Board Members shared information regarding their recent site visits, committee reports and other community related activities.

### Superintendent's Report

- Moorpark Unified School District Celebrations: The Board and Superintendent Hays recognized: 1) Dr. Rosalinda Silva for her work in coordinating and submitting all required documentation for the District's Federal Program Monitoring Audit, resulting in zero audit findings; 2) Mr. Nathan Inoyue for coordinating and submitting the District's California Green Ribbon School applications, garnering the District the Silver Award for the 2024-2025 school year; and 3) Dr. Melissa LaBelle and Dr. Lilia Magana for their work and efforts in preparing the District's preschool to be named a state demonstration site for Supporting Innovative Practices, Dr. Danny Daher, the Program State Coordinator, addressed the Board to highlight the District administrators and teachers in serving students, staff and families.
- Public Information Officer – Year End Report: Daniel Wolowicz presented a report of activities and communications generated for the District for the 2024-2025 school year.
