These assumptions reflect the legal requirement that the contingency budget not exceed the prior year's total spending, except for certain expenditures permitted by law. The district remains committed to preserving essential educational services while operating within these constraints. Key assumptions include: elimination of Erie I BOCES Technology Support Services, elimination of School Bus Purchase, elimination of Annual Capital Outlay Project Transfer

These adjustments are made to ensure that the contingency budget remains within the allowable spending limits while maintaining the district's ability to deliver a sound, basic education. The district will continue to prioritize core academic programs, mandated services, and student health and safety.
