# THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NUMBER ONE OF TULSA COUNTY, OKLAHOMA MINUTES OF THE REGULAR MEETING OF APRIL 7, 2025

A regular meeting of the Board of Education of Independent School District Number One of Tulsa County, Oklahoma, was held on April 7, 2025, commencing at 6:35 p.m., in the Cheryl Selman room, ground floor, at the Charles C. Mason Education, 3027 S. New Haven Avenue, Tulsa, Oklahoma. Notice of the meeting was given by service of written notice of the meeting to the office of the County Clerk of Tulsa County, Oklahoma, as required by Title 25, O.S., § 311(A)(5), and by posting the agenda and recommendations of the Superintendent of Schools in prominent public view in the enclosed glass display case at the main door of the Charles C. Mason Education Service Center at 6:25 p.m. and at *tulsaschools.org* at 6:24 p.m. on April 4, 2025, pursuant to the provisions of Title 25, O.S., § 311(A)(9).

# **OPENING EXERCISES**

Ms. Stacey Woolley, president of the Board of Education, called the meeting to order, roll called, and declared that a quorum of the board was present; therefore, the meeting was qualified to consider the agenda items. The flag salute was led by the Rogers High School JROTC.

Board President Woolley reminded the board and the public that the agenda, the live stream link, and supporting documents were posted on the main Tulsa Public Schools' web page. Board President Woolley and Dr. Johnson recognized the TPS Youth Advisory members, led by Tulsa Changemakers, that were in attendance.

# SUPERINTENDENT'S CORRECTION TO AGENDA

Superintendent Johnson announced a change to agenda item E.20. Maintenance/Transportation facility should be removed from the recommendation of the agenda item and the Will Rogers Field House should reflect Phase 1, metal roof so that the language aligns with the recommendation language in the agenda template.

Superintendent Johnson announced that the University of Tulsa is offering full-tuition scholarships to deserving Tulsa Public School seniors. She thanked President Carson and the TU team for working to open doors for TPS students. She recognized the scholarship recipients: Pedro Guzman-Garcia, Jesus Morena, Aiden Hood, Aiden Manuel Martinez, Esmerelda Belmontes Garcia, James George, Christian Crockett, and Jocelyn Doakson.

# SEATING OF THE BOARD MEMBERS

Board President Woolley read the following statement concerning the election of Board Member Districts 2 and 3.

"There having been presented to the Board of Education of Independent School District Number One of Tulsa County, Oklahoma, the results of the election for school board members, as shown by the official returns furnished by the Tulsa County Election Board, said Board of Education finds and declares of record that said election was conducted by the officers designated in the proclamation and notice of such election; with all vacancies filled according to law, and in all respects, as required by law; that said election was conducted by ballot in the form prescribed; that the polls were opened at 7 a.m. and remained open continuously until the polls were closed at 7 p.m. on the 1st day of April, 2025, the hours designated in said proclamation and notice of election, and that the votes cast by the fully qualified electors were as follows:

District 2:

Calvin Moniz - Opposing candidate withdrew

District 3:

Kyra Carby - 561 votes

Dorie Simmons - 281 votes

Accordingly, I hereby state that Mr. Calvin Moniz has been elected to the office of the Board of Education of Independent School District One of Tulsa County for Board Election District Number Two or Post Number Two to serve for a regular term of four years, or until his successor is elected and qualified.

Additionally, I hereby state that Ms. Kyra Carby has been elected to the office of the Board of Education of Independent School District One of Tulsa County for Board Election District Number Three or Post Number Three to serve for a regular term of four years, or until her successor is elected and qualified.

D.2 School District Attorney Eric Wade administered the Oath of Office to newly elected Board Members of Election Districts Two and Three.

Mr. Moniz shared that he appreciated joining the board for a full four-year term. He also stated that while there was not an election for the Board District Two seat it does not make the job any easier. He promised to continue to work hard for District Two and all of Tulsa Public Schools.

Ms. Carby stated that her election is a win for the community and that serving on behalf of District Three is not done alone. She stated that she is proud to serve District Three and all of Tulsa and is excited about the work to be done over the next four years.

D.3 The Board President, Stacey Woolley called for nominations for the office of president.

Board Member Sarah Smith made a **motion** to nominate Ms. Susan Lamkin to serve as President of the Tulsa School Board, and Ms. Stacey Woolley **seconded** the motion. The motion **passed** by the following vote:

D.4 The Board President called for nomination for the office of vice president.

Board Member E'Lena Ashley made a **motion** to nominate Mr. Calvin Moniz to serve as Vice President of the Board of Education. Mr. John Croisant **seconded** the motion, and the motion **passed** by the following vote:

Superintendent Johnson expressed her appreciation and admiration for the leadership of former Board President Woolley and former Vice President Croisant.

Notwithstanding, Board Member Ashley moved to place on the agenda of the next regularly scheduled meeting of the board a vote to show the board's support for the impaneling of a grand jury in Tulsa County for the purpose of investigation of criminal prosecution of prior wrongdoing in the conducting of business for Tulsa Public Schools.

Mr. Wade advised that the only matters that can be taken up under new business are matters that did not exist prior to the deadline for the posting of the agenda. He stated that the matter Ms. Ashley raised existed prior to the deadline for posting of the April 7, 2025, agenda, so it is not eligible to be considered under new business. No other members of the board discussed the matter that Ms. Ashley brought up.
