# Information: A. Student Representative Report

Alexis Frye reported on an upcoming Statehouse visit to discuss technology's impact on education, Legally Blonde: The Musical, Mr. B-P Competition, and students' concerns regarding the restrooms.

## Information: B. CyberPatriot Competition

Mr. Wallace thanked the School Committee for having them attend.

John Trainor discussed his challenges, achievements, and team building while attending the CyberPatriot National competition.

Questions were asked and answered regarding how many students attended, what is the next step, what are John's career aspirations, is the competition open to other technical areas, and if Al is used.

# Information: C. Massachusetts State and Local Cybersecurity Grant Program (SLCGP)

Mrs. Roe explained a grant was applied for and received from the State regarding Cybersecurity. She discussed the risk management recovery program plan, auditing the network, categorizing critical systems, a breach test, the procedural plan, a tabletop game, and a small cyber event which will lead to everyone becoming more prepared in the event of a cyber event.

Dr. Magalhaes added that we need safety procedures in place along with a guidebook as we have to be prepared for cyber attacks. He said Mrs. Roe is doing a great job educating the staff.

Questions were asked and answered regarding the amount of the grant, if there has ever been a breach or cyber attack and if so how many attempts, two factor authentication, what is in place now in the event of a cyber attack, will everything change after the move to the new building, and if backups are on or off campus.

## Information: D. MSLA Bookmark Contest

Dr. Magalhaes informed the Committee that Cayden Morazes, a Grade 10 DVC student, won the statewide bookmark contest for the high school division 5. The awards ceremony was held on March 30.

## Information: E. 2025 DECA State Conference

Dr. Magalhaes reported that the 2025 DECA State Conference was held from February 27 to March 1 in Boston. Eleven students will go on to participate at the International Conference in Orlando later this month.

# Information: F. 2025 BPA State Leadership Conference

Dr. Magalhaes reported that the 2025 BPA State Leadership Conference was held on March 8-9 in Norwood. Twenty-nine students attended and 17 students will go on to Nationals in Orlando in May.

#### Information: G. Student Mental Health and Wellness Grant

Dr. Magalhaes informed the Committee that we received a \$43,800 grant from DESE to support socialemotional learning, mental health, and wellness initiatives.

## Information: H. READS

Dr. Magalhaes reported that READS is looking to purchase a building for their deaf and hard of hearing students. They have found a building they can purchase and will have it paid off in five years. There is no cost to B-P; this is informational only.
