As of the 11th day of February, 2020, Independent School District No. 11, Tulsa County, Oklahoma, has 5 General Obligation bond issue(s) outstanding:

- \$12,675,000 Combined Purpose Bonds of 2015, dated May 1, 2015 (\$3,180,000 outstanding in principal as of the 11th day of February, 2020);
- \$1,875,000 Building Bonds of 2016, dated May 1, 2016 (\$940,000 outstanding in principal as of the 11th day of February, 2020);
- \$2,130,000 Transportation Equipment Bonds of 2016, dated August 1, 2016 (\$710,000 outstanding in principal as of the 11th day of February, 2020);
- \$9,645,000 Building Bonds of 2017, dated March 1, 2017 (\$6,430,000 outstanding in principal as of the 11th day of February, 2020); and
- \$18,900,000 Combined Purpose Bonds of 2018, dated January 1, 2018 (\$14,900,000 outstanding in principal as of the 11th day of February, 2020).

The School District has \$52,465,000 in unissued building bonds authorized at an election held on the 10th day of October, 2017. These bonds will be used to complete the constructing, furnishing, equipping and/or acquiring of a new elementary school; a gym/safe room addition at Smith Elementary; improvements throughout the district to include, but not be limited to, facility upgrades; a new administration building; a classroom addition and safe room and renovate existing classrooms at the high school; and complete the acquisition and installation of new turf.
