**A RESOLUTION OF THE BOARD OF EDUCATION OF THE OAK GROVE SCHOOL
DISTRICT ADOPTING AND APPROVING THE ASSOCIATE MEMBERSHIP
AGREEMENT JOINING THE HEALTH AND WELFARE BENEFITS
JOINT POWERS AUTHORITY**

WHEREAS, the Oak Grove School District's (District) insurance premiums for health and welfare coverage have been steadily increasing over the past three years;

WHEREAS, the District has been considering methods to procure cost-effective health and welfare insurance coverage;

WHEREAS, Title I, Division 7, Chapter 5, Article 1, (Section 6500 et seq.) of the Government Code authorizes joint exercise by two or more public agencies of any power common to them, and;

WHEREAS, the governing Board of Oak Grove School District ("District") has considered the proposed Interagency Participation Agreement Alliance of Schools for Cooperative Insurance Programs Health Benefits Program, a draft of which is attached hereto as Attachment 1, under which the District will become an associate member of the Alliance of Schools for Cooperative Insurance Programs ("ASCIP");

WHEREAS, the District has determined that health and welfare coverage by combining its efforts with other California school districts to establish, operate, and maintain a Joint Powers Authority (JPA) is the most effective solution for meeting these goals;

NOW THEREFORE BE IT RESOLVED THAT:

The Governing Board of Oak Grove School District hereby declares and formally approves its membership in the Alliance of Schools for Cooperative Insurance Programs ("ASCIP"), a California Joint Powers Authority, and instructs its duly authorized agent to execute and deliver on its behalf any necessary or appropriate documents to carry out the intent of this resolution including the Interagency Participation Agreement Alliance of Schools for Cooperative Insurance Programs Health Benefits Program and any agreements necessary to participate in the Alliance of Schools for Cooperative Insurance Programs Health Benefits Program.

The Governing Board authorizes the Superintendent or designee to appoint the District's Business Services Division or Human Resources Division, or a person with equivalent duties and background in health and welfare benefits procurement, who shall serve as the authorized representative to the JPA.
